WHEREAS, The York City Human Relations Commission will have exhausted all funds appropriated for its Salary/Wages account # 10-160-40010-21311 effective November 15, 2012; and

WHEREAS, The Deputy Business Administrator for Human Resources has estimated \$ 7,517.11 is needed to cover payroll through December 31,2012; and

WHEREAS, The salaries of the York City Human Relations Commission employees have been funded and supplemented by the U.S. Department of Housing and Urban Development, through the use of the Fair Housing Assistance Program (FHAP) Grant in the past, as an approved use under the FHAP Cooperative Agreement for Case Processing Funds; and

WHEREAS, The York City Human Relations Commission is requesting a transfer in the 2012 in the Fair Housing Assistance Program to cover salaries and wages; and

WHEREAS, Case Processing Funds remain in the 2012 Budget from grant years 2007, 2008, and 2009 totaling \$ 9,861.39, and

WHEREAS, Collectively \$9,861.39 needs to be transferred to the Salary/Wages line items 10-160-40010-21307; 10-160-40010-21308, and 10-160-40010-21309, through the amounts listed below to cover salaries/wages throughout the remainder of 2012, and

WHEREAS, the Finance Department will calculate the necessary FICA on said wages to be applied to the following account lines, 10-160-41010-21307, 10-160-41010-21308, 10-160-41010-21309

WHEREAS, said transfers exceed five percent (5.0%) of the appropriated item within said funds; and

WHEREAS, in accordance with Article 137.02 (b) of the Codified Ordinance of the City of York, such transfer shall require an affirmative vote of at least four members of Council.

NOW, THEREFORE, BE IT RESOLVED, by the Council of the City of York, Pennsylvania that Council hereby approves the transfers in accordance with the following schedule:


