

WHEREAS, The York City Human Relations Commission is requesting a transfer in the 2012 Budget in the Fair Housing Assistance Program to cover salaries and wages; and

WHEREAS, Resolution No. 110 of Session 2012 approved the use of \$10,322.00 from the Fair Housing Assistance Program Grant from the U.S. Department of Housing and Urban Development, to supplement salaries for the York City Human Relations Commission; and

WHEREAS, the \$10,322.00 needs to be transferred to the Salary/Wages line item 10-160-40010-21311; and

WHEREAS, said transfers exceed five percent (5.0%) of the appropriated item within said funds; and

WHEREAS, in accordance with Article 137.02 (b) of the Codified Ordinance of the City of York, such transfer shall require an affirmative vote of at least four members of Council.
