**WHEREAS**, the City desires to amend the 2015 City Budget to reflect the changes resulting from actual funding levels rolled over from 2014; and



**AN ORDINANCE**

Amending Article 931 "Sanitary Sewers," Subsection 931.08(a) "Hotels and Restaurants," of the Codified Ordinances to include language that requires all commercial food preparation establishments to install grease interceptors on fixtures.

WHEREAS, the City of York, Pennsylvania has adopted Article 931 "Sanitary Sewers" of the York City Codified Ordinances establishing certain requirements and responsibilities regarding discharge into the sanitary sewer system; and

WHEREAS, Article 931.08(a) "Hotels and Restaurants" requires that certain establishments be equipped with grease interceptors; and

WHEREAS, it is necessary to ensure that the discharge of grease from food preparation establishments be eliminated from the sanitary sewer system;

NOW, THEREFORE, BE IT ORDAINED, that the Council of the City of York, Pennsylvania hereby amends Article 931.08(a) "Hotels and Restaurants" as follows:

**931.08 HOTELS, RESTAURANTS AND FOOD PREPARATION ESTABLISHMENTS.**

(a) All hotels, restaurants, boarding houses, **commercial food preparation establishments** and public eating places, before draining into the sewage system, shall install grease interceptors on fixtures as required by the City of York.


This ordinance shall become effective twenty days after approval by the Mayor.


