**CITY BUSINESS GUIDELINES FOR BOOTH RENTALS**

1. The Olde York Street Fair is a craft fair. Please keep this in mind when you make the decision to participate in this event.
2. IF AN OPEN DOORWAY IS ALL YOU NEED, PLEASE DO NOT REQUEST A BOOTH SPACE. If you have ever been to the Olde York Street Fair you know how crowded it can get. Please leave the booth spaces available for crafters and non-profit groups if you really don't need the booth space.
3. All items placed in business booth should be First Quality. No clearance items please. Items can be "On Sale."
4. The Olde York Street Fair Committee encourages businesses to come up with something unique. Perhaps one of your vendors has a special event promotional item.
5. If you will be renting a booth space, what will you be selling or promoting that we might be able to mention in our publicity. \_\_\_\_\_

7. All tables placed in your booth space must be draped to the sidewalk. All trash generated from your booth must be returned to your business and disposed of in the manner of usual business trash.

9. No city electric is available. Please make arrangements to use your business electric if needed.

(Note: Booth space will be located in front of your business; however, because of the measuring of the street some slight realigning might be necessary for efficient use of street spaces. You will be assigned a booth number. Please make sure you are set up within those boundaries.)
