CALL TO ORDER: President Helfrich called the June 6, 2017 general public comment session to order at 6:30 p.m., in Council Chambers, 101 S. George St., York, PA, with the following members present: Judy A. Ritter-Dickson, Sandie Walker, Renee S. Nelson, Henry Hay Nixon, Vice President, and Michael Ray Helfrich, President, with President Helfrich presiding.

Members of the Administration in attendance included: Jason Sabol, Assistant Solicitor.

Members of York City Council staff in attendance included: Dianna L. Thompson-Mitchell, City Clerk.

I. Public Comment: 6:30 p.m.

Jerry King, York, PA, discussed a property in the 800 block of S. Duke St. (rear) with trees growing to the point the sidewalk is pushing up and shrubs are over-grown. He said he believes there is a home illegally renting out rooms and that he's reported it but nothing has been done.

Richard Olbit, York, PA, said nothing has been done with the parking issues in his neighborhood and he wants lines painted on the street for parking. He then talked about trees with over-hanging limbs causing a safety hazard for residents. He said one of the trees is growing up through the chimney. Mr. Olbit stated that he reported his issues to PP&Z and one response received was that he's responsible for trimming the tree. He disagrees.

Jeff Kirkland, York, PA, said he got a citation for \$184 for putting his trash out too early and he felt that was an extremely high fine for a first time offender and that he should have been given a warning first. Next, he discussed the marijuana legislation and said he supports decriminalization of marijuana. He said African-American communities are most affected by the criminalization of marijuana which tends to be the gateway to a life of crime.

Kathy Morris, York, PA, said her neighbor knocked her down last summer and a police officer came but said she must not have been hurt that bad because she didn't call for an ambulance. She shared other confrontations between her and her neighbor and how the police have been ineffective. Ms. Morris then discussed a car parked in front of 452 Park Place with a bunch of tickets on it. She'd like a sign erected for no parking.

Michelle Hans stated that she supports decriminalization of marijuana because an arrest for a small amount of marijuana could have a negative impact on the rest of someone's life.

Daniel Massey, Carlisle, PA, gave statistics about medical marijuana. He discussed several patented uses for marijuana and feels he should have the right to use this non-deadly plant for legitimate reasons. He supports decriminalization of marijuana.

Les Stark, Reading, PA, Executive Director Keystone Cannabis Corporation, said they organized three rallies in the City of York. He too supports decriminalization of marijuana. He gave statistics on the number of arrests in York for

marijuana. He said if PA retains the status quo then tens of thousands of PA residents will have their lives disrupted at exorbitant costs to maintain the criminalization of this plant. He said Philadelphia & Harrisburg have decriminalized marijuana and he hopes York will follow suit. He said the proposed ordinance does not decriminalization marijuana, it just downgrades the penalty. He said we need statewide decriminalization laws. He said his organization does oppose the cost of the fines outlined in the proposed legislation.

Tina Charles, York, PA, also supports decriminalization of marijuana because there are more serious crimes occurring in the City of York. She discussed how race plays a role in arrests for possession of marijuana with African-Americans being arrested at higher rates than any other race.

Shane Cannon Coolbaugh, York, PA, supports the decriminalization of marijuana. He said he was busted for smoking a small amount of weed, which was reported to his school. He was kicked out of school and sent to an alternative school, which negatively affected his life.

Franklin Williams, York, PA, said we've heard some moving stories this evening and he hopes Council will consider adopting this ordinance.

Chris Prince, Hanover, PA, said he was diagnosed with lymphoma which sent him on a journey to be healthy so he's in support of decriminalization of marijuana.

Michael Heiss, Lancaster, PA, supports decriminalization of marijuana. He said the myth is that if someone smokes weed they will seek harder substances - which he said is not true.

Mary Eckstine, West York, PA, supports decriminalization of marijuana. She said Harrisburg, Philadelphia, and State College have made moves on decriminalization and hopes that York steps up to the plate too.

There being no further public comment, President Helfrich adjourned the public comment session at 7:24 p.m. and immediately convened in legislative session.

Resolution No. 59, Session 2017, A Resolution authorizing a lease agreement with West York Borough to lease office space located at 1381 W. Poplar St. to the York City Human Relations Commission, was introduced by Helfrich, read at length, and on motion of Helfrich, seconded by Ritter-Dickson, Resolution No. 59 came up for discussion.

In an email received from Assistant Solicitor Sabol, he explained the following:

"I received the agreement the City Clerk attached to the previous email from West York's Solicitor a couple minutes ago. It was passed by the West York Council and, when coupled with the lease agreement, meets the requirements of our ordinance for a statement of intent for a governmental unit seeking an affiliation agreement."

"As we previously discussed, this is a stop gap measure designed to allow the HRC to start physically operating in West York while West York, the HRC, and the City determine what ultimate level of involvement West York wants to have with the HRC. As it would stand if you adopt this lease and affiliation, the HRC would be able to operate out of West York and would enter into a lease with West York, but the services the HRC provides to the citizens of West York have not yet changed. The HRC would still be offering the same advisory services it always has. The City's HRC would not handle investigations into allegations in West York, but would assist West York citizens with filing the proper forms with the State HRC office, give them contact information etc... Essentially, the status quo is maintained, but the office is located in West York."

"Currently, the HRC's computers are in storage and they are operating out of the HR conference room with no direct phone lines. It is very difficult for the HRC to be productive with the current arrangement. This agreement allows the HRC to move forward, while still giving all interested parties the necessary time to develop a long term relationship and strategy."

President Helfrich said he's not sure he agrees that the Resolution passed by West York Borough meets the affiliation agreement criteria but he supports moving forward.

There being no further discussion, Resolution No. 59 PASSED by the following vote: Yeas – Ritter-Dickson, Walker, Nixon, Nelson, Helfrich – 5; Nays – 0.

President Helfrich explained that this is federal funding, not city taxpayer dollars, but he agrees it would be nice to have that money returned to the city.
