CALL TO ORDER: President Helfrich called the July 18, 2017 general public comment session to order at 6:30 p.m., in Council Chambers, 101 S. George St., York, PA, with the following members present: Judy A. Ritter-Dickson, Sandie Walker, Renee S. Nelson, Henry Hay Nixon, Vice President, and Michael Ray Helfrich, President, with President Helfrich presiding.

Members of the Administration in attendance included: Michael Doweary, Business Administrator; Shilvosky Buffaloe, Interim Director of Economic & Community Development; James Crosby, Director of the Bureau of Housing Services; Tammy Harvey-Bethea, Program Funding Analyst; and Jason Sabol, Assistant Solicitor.

Franklin Williams, York, PA, said people are increasingly parking in front of the fire hydrant across from his house and he's having trouble getting a response to his complaints.

Establishing Article 718 "Marijuana Possession" of the Codified Ordinances. (View)

Introduced by: Judy A. Ritter-Dickson Originator: Council (Ritter-Dickson)

Final Passage of Bill No. 22, Ordinance No. 20, Session 2017, A Bill establishing Article 718 "Marijuana Possession," which was introduced by Ritter-Dickson at the June 6 meeting of Council, and read by short title, came up for final passage. On motion of Ritter-Dickson, seconded by Walker, Bill No. 22 came up for discussion.

MOTION TO AMEND. President Helfrich said he spoke with Assistant Solicitor Sabol about including paraphernalia into the definitions but was informed that we do not have the legal authority or standing to include paraphernalia. President Helfrich said he would then like to offer an amendment to section 718.99 "Penalty" to expand the ability to use community service to offset monetary fines and to allow the court to determine how long the community service should be. Therefore, President Helfrich made a motion to amend as follows:

718.99 PENALTY.

- (a) The penalty for a violation of subsection 718.02(b)(1) of this Section by an adult shall be a civil fine of one hundred dollars (\$100.00) for a first offense; two hundred fifty dollar (\$250.00) for a second offense; and five hundred dollars (\$500.00) for a third offense in a five year span. Any subsequent offense over third offense in a five year span will fall outside of this ordinance and shall be charged in accordance with Federal and Pennsylvania law. The court may in its discretion suspend the fine imposed under this subsection 718.02(b)(1) for an first offense if the person found liable agrees to and does in fact perform such community service as the court deems appropriate, up to nine hours.
- (b) The penalty for a violation of subsection 718.02(b)(2) shall be a civil fine of one hundred fifty dollars (\$150.00) for a first offense; three hundred dollars (\$300.00) for a second offense; and six hundred dollars (\$600.00) for a third offense. The court may in its discretion suspend the fine imposed under this subsection 718.02(b)(2) for an first offense if the person found liable agrees to and does in fact perform such community service as the court deems appropriate, up to nine hours.

VOTE ON MOTION TO AMEND. The motion to amend was seconded by Walker and PASSED by the following vote: Yeas – Ritter-Dickson, Walker, Nelson, Helfrich – 4; Nays – Nixon – 1.

Franklin Williams, resident, said he is in support of this legislation because it gives offenders a second chance and allows the police to deal with the more serious crimes affecting our city.

President Helfrich explained that this legislation only affects adults but that we should have a discussion on how to address young offenders. Additionally, he clarified that this legislation does not legalize marijuana but aims to keep this violation from being criminal for small possession.

Nicolas Longstreet, York County Policy Council, Kristie Billet, Pennsylvanians for Safe Access, and Michele Hans, Manchester Township, all spoke in support of this legislation.

Less Stark, Executive Director of Keystone Cannabis, Reading, PA, said they have had rallies in the past and have seen strong community support for decriminalizing marijuana possession. He discussed penalties and his support of community service but disagrees with not being able to decriminalize paraphernalia because he said this has been passed in other municipalities so more research should be done on this. He also suggested passing a resolution to make possession of marijuana the lowest priority offense and to support statewide decriminalization of marijuana. He said HB 925 & 928 are currently in the judiciary committee to further legislate decriminalization so a resolution of support might give them a push to act on this legislation.

Dan Massey, Carlisle, PA, agreed with Mr. Stark and added the health benefit aspect. He shared his medical challenges from side effects of medicine. He said the side effects ruined his life. He then

compared those effects to the side effects of marijuana, which pale in comparison to his previous medicines. Mr. Massey stated that he too supports this legislation although he said decriminalization is not enough because this is just a plant that doesn't kill anybody. He said he's not in agreement with removing the limits on community service because this could turn into indentured servant.

Chris Goldstein, <u>philly.com</u>, said he helped draft the ordinance passed in Philadelphia decriminalizing marijuana. He said the numbers were rising for marijuana possession but when Philadelphia passed this legislation, there was a huge decline in arrests, which reduced costs. He then gave the numbers on York's arrest profile for 2016, which included more arrests of minorities than whites.

President Helfrich encouraged residents to continue to lobby the Commonwealth to decriminalize marijuana.

Police Chief Kahley said he takes offense to the racial reference for marijuana arrests. He said you can change statistics to make it whatever you want and that they are making arrests based upon crime, not skin color.

There being no further discussion, Bill No. 22, Ordinance No. 20, as amended, PASSED by the following vote: Yeas – Ritter-Dickson, Walker, Nixon, Helfrich – 4; Nays – Nelson – 1.

President Helfrich called for a recess at 7:42 p.m. and reconvened the meeting at 7:50 p.m.

President Helfrich said he wants to include that the HRC will fulfill its powers under Article 185.10(b)(6) of the codified ordinances, which reads:

"To study the problems of discrimination in all or specific fields of human relationships when based on race, color, familial status, religious creed, ancestry, age, sex, national origin, disability, sexual orientation, gender identification, or the use of a guide or support animal because of the disability of the user or because the user is a handler or trainer of support or guide animals, and foster, through community effort or otherwise, good will among the groups and elements of the population of the City, as well as seeking the creation of a joint City-County Commission on Human Relations."

Assistant Solicitor Sabol said the affiliation agreement can be as big or as small as Council wants and he's not opposed to adding the additional language although what the HRC does when in West York is the same thing they did when they were in the County offices, which is take in county residents complaints and refer them to the state HRC.

President Helfrich also said the language in the 4th whereas clause wherein it states the affiliation agreement is "strictly for the purposes of leasing office space" doesn't seem to cover the provisions of an affiliation agreement. He said to merely say you're renting is not an affiliation agreement.

MOTION TO AMEND. After he outlined his proposed amendments, President Helfrich made a motion to amend Resolution No. 68 as follow:

Business Administrator Doweary explained that this is a service that is provided annually. We are looking at making some adjustments such as undertaking a traffic study, followed by a look at all intersections to assess traffic patterns for kids coming from and going to school, as well as possible recommendations for adjustments. Also, he stated that the school district would like to reduce their contribution for crossing guard services from 75% to 50%. The concern is the timing of their request as our budget is already set for 2017 and we'd have to figure out this deficit. He said Richard Snodgrass, Business Administrator for the School District, is relaying this information to him but he will follow up with developments as the arise. If the reduction is approved, then that will result in a reduction of coverage, he stated.

Summary of the Bond:

The City of York General Authority (the "Issuer"), a municipal authority incorporated by the City, existing under the Pennsylvania Municipality Authorities Act, 53 Pa.C.S. Chapter 56, of the Commonwealth, has approved acting as a conduit issuer on a tax-exempt obligation in the maximum principal amount of \$10,000,000 (the "Tax-exempt Note"), the proceeds of which will be used to finance a refunding project that includes retiring all or a portion of the \$11,700,000 original principal amount Promissory Note (Federally Taxable), dated October 30, 2009 (the "County Note"), issued by the Borrower (the "York County Agricultural Society") to the County of York, Pennsylvania, refunding other debt obligations of the Borrower related to LED lighting and working capital, and paying related costs and expenses (the "Refunding Project")

Resolution No. 73, Session 2017, A Resolution approving the first phase of the rezoning and map amendment project for 300 N. State St. (former Danskin facility) owned by the RDA for redevelopment of the 4.2-acre site with approximately 40 affordable rental townhouses for low-to-moderate income families mixed with a community center to support the development and possible small scale commercial retail and service uses, was introduced by Nixon, read at length, and on motion of Nixon, seconded by Nelson, Resolution No. 73 came up for discussion.

As outlined in the talking points submitted by Director Buffaloe, he explained that The Department of Community and Economic Development has identified neighborhoods where the existing zoning is negatively restrictive, suppressing a variety of development that would benefit the community as a whole, or where the zoning does not correspond to the current neighborhood fabric and goals. DCED would like to explore the rezoning of these neighborhoods, which would identify possible zones that would allow for development that would better fit the residents and their needs. As such, we request that City Council engage the Planning Commission in a zoning map amendment exercise for the neighborhood located in the northeast section of the City of York that is historically industrial in nature.

Vice President Nixon clarified that adopting this Resolution does not mean Council is approving the rezoning at this time. Director Buffaloe said that is correct.

Resolution No. 74, Session 2017, A Resolution exonerating municipal taxes, interest, penalties and fees in the amount of \$12,747.70 for the property known as Penn Market identified as 382 W. Market St., 366-368 W. Market St., and 380 W. Market St., was introduced by Nixon, read at length, and on motion of Nixon, seconded by Walker, Resolution No. 74 came up for discussion.

Michael Black, Chair, York City Redevelopment Authority, explained that this is a request to exonerate municipal taxes for the property known as Penn Market. He identified the parcels as 382 W. Market St., 366-368 W. Market St., and 380 W. Market St. and stated that the RDA intends to take ownership of the Market, negotiate agreements to reduce the debt associated with the asset, begin an in-depth study of all that is needed to stabilize operations, and maintain this asset for another 125 years. Mr. Black went on to say that a very important part of the Market's debt is its overdue taxes and as the RDA is immune from taxes and is not able to pay back taxes on behalf of the Market, an exoneration of all municipal taxes, interests, penalties and fees is being requested.

Vice President Nixon said although he does not generally support exonerating taxes, this is an exit strategy and the marketability for the west side of town is important so this will allow for future taxable development.
