Brenda Drayden, resident, stated that the intersection of Harding Court & S. Queen St. needs better traffic safety mechanisms because of the number of accidents occurring at this intersection. She then discussed parking concerns for parents picking up their children at York Academy Regional Charter School located at 32 W. North St. She asked if the empty dirt lot on the corner of N. Beaver St. and North St. could be used for overflow parking. Director Buffaloe said that lot is owned by the RDA and early on was offered as overflow parking but there are safety issues that need to be abated and therefore the lot is no longer offered for that use.
