CALL TO ORDER: President Helfrich called the December 19, 2017 general public comment session to order at 6:30 p.m., in Council Chambers, 101 S. George St., York, PA, with the following members present: Judy A. Ritter-Dickson, Sandie Walker, Renee S. Nelson, Henry Hay Nixon, Vice President, and Michael Ray Helfrich, President, with President Helfrich presiding.

Members of the Administration in attendance included: Jason Sabol, Assistant Solicitor.

Members of York City Council staff in attendance included: Dianna L. Thompson-Mitchell, City Clerk.

I. Public Comment: 6:30 p.m.

Jerry King, resident, said another overdose victim was pulled from the property on S. Duke St. that he's been complaining about. He said it's a recovery house and when the ambulance was called there was no one there supervising the house. He asked how many more dead bodies will need to be removed from the house before something is done.

Franklin Williams, resident, said recovering addicts are a protected class under the laws of the ADA but he thinks Council has the power to reasonably regulate recovery homes. He said he has 2 or 3 in his neighborhood, but they aren't a problem because they are well run and supervised. Next, Mr. Williams said a large cardboard box was set out for the trash that was stuffed with a bunch of smaller boxes. He said if he was a trash collector he would have taken it, but it wasn't taken because it didn't meet the recycling limitations. He said if it were him he wouldn't have the energy to drag those boxes back into his house while trying to figure out what he did wrong. Mr. Williams stated that he wishes there was some leniency especially when you know the person is trying to do the right thing. Lastly, Mr. Williams discussed the ongoing complaint about Mayor-Elect Helfrich's eligibility to serve as Mayor because of his decade old felony. He said he just wishes people would leave this alone and accept that Mayor-Elect Helfrich ran and won a successful election campaign.

Greg Shenk, Maillie, LLC – Brief report on the 2016 City of York audits.

Mr. Shenk presented the financial audit report through December 2016. He said the City has complied with all accounting standards required by GASB. He then outlined highlights of the audit and answered questions from Council. He said the city had a negative fund balance in the beginning of the year but has risen out of that deficit. Although the city still has challenges to overcome such as the pension obligations, he said progress is being made. He stated that his firm has presented a clean, unmodified opinion which was a lot of work and a lengthy process and city staff was great in providing the information they needed. Mr. Shenk then reviewed the single audit report and discussed some notable findings. He said the city has made strides in such a difficult environment and the pension challenge is something all municipalities are facing across the Commonwealth.

Princess St., was introduced by Nixon, read at length, and on motion of Nixon, seconded by Walker, Resolution No. 117 came up for discussion.

Vice President Nixon said there were several items involved in this application. He outlined the work to be done and why HARB denied it. He said he feels HARB's recommendations will create an undue financial burden on the applicant. He said he is not in favor of removing the balcony and replacing the columns but he has concerns about HARB's recommendation to install custom made balusters to the

railing. Vice President Nixon stated that he would consider allowing replacement of ready-made balusters instead of custom made ones which would be more cost effective for the applicant.

President Helfrich said he has a concern about the pickets being removed and the applicant not responding as to what happened to them.

Vice President Nixon said it's clear that 2/3 of the balusters/railings have been replaced with something modern and 1/3 are original. He did say the general construction or repair of the supports under the balcony are sort of haphazard and looks structurally unsound.

President Helfrich said he recommends the applicant reapply to HARB with an amended application based on the recommendations noted by Vice President Nixon.

There being no further discussion, the Resolution PASSED by the following vote: Yeas – Ritter-Dickson, Walker, Nixon, Nelson, Helfrich – 5; Nays – 0. (This vote means Council approved HARB's recommendation to DENY the application.)

- 2. <u>The earlier of (a) submission of land development plans by Saddleback Properties, LP (or an affiliated entity) for development of the surrounding parcels, or (b) any requirement of street vacation from any entity providing funding to Saddleback Properties, LP (or an affiliated entity) for its development project.</u>

<u>SECTION 4: These contingencies shall not apply to vacating Maple Alley and a portion of</u> <u>Winterset Avenue as contemplated in the proposed ordinance.</u>

SECTION 3 5: This ordinance shall become effective in accordance with the law.
