Franklin Williams, resident, discussed the recent mass shooting at Stoneman Douglas High School in Parkland, Florida that claimed the lives of 14 students and 3 faculty members and how guns are negatively affecting our community. He said we need to take action now against gun violence.

Authorizing acceptance of TAP Reimbursement funds. (\$255,195) (<u>View</u>) Introduced by: Sandie Walker Originator: Public Works

Resolution No. 24, Session 2018, A Resolution authorizing acceptance of Transportation Alternatives Program (TAP) funding from PennDot in the amount of \$255,195.00, was introduced Walker, read at length, and on motion of Walker, seconded by Washington, Resolution No. 24 came up for discussion.

Director Green explained that funding was originally received in 2017 (\$147,624.00) for the East & West King St. bike lanes project, however, the project came in a little over budget, so this will close that funding gap. The project will involve revamping the bike lanes, which are currently located on the inside lane of traffic. He said we will rework the flow to make it safer for bikes, motorists, and vehicles parked along the east to west corridor of King St. He said no taxpayer dollars being used for this project.

There being no further discussion, Resolution No. 24 PASSED by the following vote: Yeas – Washington, Ritter-Dickson, Buckingham, Walker, Nixon – 5; Nays – 0.

Authorizing submission of a TE-160 Application for Traffic Safety Approval form to PennDOT. (<u>View</u>) Introduced by: Sandie Walker Originator: Public Works

Resolution No. 25, Session 2018, A Resolution authorizing submission of a TE-160 Application for Traffic Safety Approval from PennDot to install a new traffic signal, was introduced by Walker, read at length, and on motion of Walker, seconded by Ritter-Dickson, Resolution No. 25 came up for discussion.

Director Green stated that the York Academy High School is currently being built with a projected completion date of July 2018. He said we would like to get traffic mechanisms in place before the 2018-2019 school year begins to help slow down traffic, so we plan to move the traffic light from Jefferson Ave. to Hamilton Ave., add turning lanes, and put a stop sign at Jefferson Ave. and S. George St.

Mayor Helfrich said pedestrian and traffic safety are of concern along the S. George St. corridor, so more projects will be forthcoming to make travel along this corridor safer.

Councilman Buckingham asked if turns will be prohibited from turning left off Jefferson Ave. onto S. George St. Director Green said since a stop sign will installed at Jefferson Ave. & S. George St., for safety reasons, at this point we will prohibit left turns off Jefferson Ave. onto George St. He stated that they want to get a better idea of traffic flow because they certainly don't want vehicles trying to cross two lanes of traffic from a stop sign.

There being no further discussion, Resolution No. 25 PASSED by the following vote: Yeas – Washington, Ritter-Dickson, Buckingham, Walker, Nixon – 5; Nays – 0.

Mayor Helfrich said we recently discussed street cleaning schedules when talking about commercial districts and possibly changing the time to not interfere with commercial activities. He said residents can send him an email since the conversation is currently active. Although he can't guarantee schedule changes, he said he's open to hearing residents' arguments on the issue.

President Nixon asked if the Administration will be doing press releases in the more traditional sense instead of posting on Facebook because he would rather receive email notification. Mayor Helfrich said his office sends out press releases on social media as well as email and he will double check that Council members are included on all emailed press releases.
