Vice President Walker stated that in an email received from Acting Director Chaz Green, he explained that the City of York has been awarded another \$200,000.00 under the Pennsylvania Department of Conservation and Natural Resources Department Local Stormwater BMP Implementation Grant Program. This funding will be used in conjunction with the \$200,000.00 received from DEP to work on the stream bank restoration of Poor House Run.

Vice President Walker stated that in an email received from Acting Director Chaz Green, he explained that the City of York has been awarded \$180,000.00 under the Pennsylvania Department of Community and Economic Development Early Intervention Grant Program. This funding will be used to complete a Capital Needs Assessment on all of streets, parks, and buildings. This will provide a cost estimate of maintaining our properties over a 5 to 20-year time span. The assessment will assist the property by setting up a budget for the projected amount of years and also informs us of immediate needs on our properties.
