If at all possible, vendors requesting their 2018 location will be given that same space for the 2019 show. Vendors requesting a change of location from their 2018 space will be processed next, followed by new applications in date received order. APPLICATIONS RECEIVED AFTER MARCH 22 WILL BE ACCEPTED ON A SPACE AVAILABLE BASIS UNTIL 4:00 P.M. FRIDAY, APRIL 5, 2019.

Rental fee is **\$90 per booth PLUS \$10 non-refundable application fee.** Make check payable to **YORK CITY RECREATION & PARKS**. Booth size is 15' wide x 10' deep and <u>all items **must fit within this space**</u>. There is a \$25 fee for checks returned for insufficient funds.

GUIDELINES FOR OLDE YORK STREET FAIR CRAFT VENDORS

The intent of the Olde York Street Fair is to offer crafts persons and non-profit charitable and educational organizations an opportunity to sell their handiwork and/or food to raise money for their cause or organization.

- 1. Crafts are to be made or grown by craft vendor. No paid employees may have been used to make or grow your item(s). It is understood that to make crafts, manufactured items such as shirts, beads, earring backs, pin backs, etc. must be used. However, the final craft product must be an assembly of these items by the vendor. No second party crafts, no imports, no manufactured items, no resale items. If you are unclear if your entry fulfills our requirements, please email events@yorkcity.org or call 717-854-1587 to discuss your application.
- 2. All craft vendors are REQUIRED to submit photos with application to verify that crafts being sold at the Olde York Street Fair are handmade.
- 3. The following types of participation are allowed at the Olde York Street Fair.
 - Handcrafted products created by the exhibiting artisans ("for profit" vendors)
 - Displays by non-profit groups
 - Displays by political candidates to provide information to voters
 - Non-profit sale of food, beverages, and organizational related items by certified non-profit organizations
 - Store owners or permanent street vendors along route of Street Fair
 - Demonstrations of quality crafts, special food vendors, or permitted novelty vendors as contracted by the City of York
 - Event sponsors
- 4. The Olde York Street Fair is a rain or shine event. **Be prepared for rain with adequate covering and items to weigh down your booth in case of wind.** No refunds will be given for inclement weather.
- 5. <u>Electricity is not available for crafters</u>. Due to several requests and changing technology, we will allow small whisper quiet generators in certain sections of the show, but you must tell us in advance. Please note: if you are a returning vendor and wish to bring a quiet generator, it may result in your space assignment being changed depending on where you are located.
- 6. **NO PETS**, no boom boxes, no bikes, no skateboards, no in-line or roller skates.
- 7. The Olde York Street Fair officially runs from 12:30 to 6:00 p.m. Booth set up begins at 8:30 a.m. <u>REGISTRATION ASSISTANCE WILL NOT BE AVAILABLE UNTIL 8:30 A.M.</u> Informal selling of craft or food items before the start time detracts from the event and creates a lower caliber event overall. Therefore, pre-event start time sales will not be permitted. Please use extreme courtesy for area residents and church services and minimize noise at these locations. You must be unloaded and your vehicle removed from the festival area by 11:30 a.m. If you arrive after 11:30 a.m., we cannot guarantee access to a space and no refunds will be given.
- 8. Please bring all your own equipment such as chairs, tables, tablecloths and canopies. All tables must have table covering to sidewalk and all items must fit within your assigned booth space (15' wide by 10' deep).

- 9. Names of all vendors selling goods and merchandise will be forwarded to the Pennsylvania Department of Revenue. <u>ALL VENDORS MUST HAVE A CURRENT PENNSYLVANIA</u>

 <u>SALES TAX LICENSE (PERMANENT OR TEMPORARY)</u>. You cannot be accepted without a valid license number. To obtain a temporary sales tax license, please apply online at www.pa100.state.pa.us/ or call the PA Revenue Office at 717-425-7700.
- 10. Insurance or disclaimer must be provided by craft vendors. Certificate must name the City of York as the insured party.
- 11. Representatives of the Olde York Street Fair will visit vendor booths to review compliance with guidelines. Those not complying with guidelines could be asked to leave the event and will not be given a refund.
- 12. Vendors who do not comply with the guidelines of the event will not be allowed to participate in future Olde York Street Fairs even if they are allowed to remain at the present event.
- 13. No subletting of space is allowed.
- 14. **If your booth includes the sale of food items**, whether you are sampling or not, you MUST apply for a Special Event Health License and the City of York Health Inspector will visit your booth. This should be done at least three weeks prior to the event. You may download the guidelines and application at yorkcity.org or email events@yorkcity.org to have the documents emailed to you.
- 15. If you are admitted to the 2019 Olde Street Fair and are not present, you forfeit your same space number for future York City Olde York Street Fairs.
