Activity/Entertainment Vendor Guidelines

1. The Olde York Street Fair officially runs from 12:30 p.m. to 6 p.m. Vendor placement and set-up time notifications will be sent with confirmation letters after April 15, 2019.
2. Olde York Street Fair is a rain or shine event. Be prepared for rain with adequate covering of your booth and bring adequate weights for your tent and items. No refunds will be given for inclement weather.
3. Waste generated by vendors must be discarded by vendors.
4. Names of all vendors will be forwarded to the Pennsylvania Department of Revenue. ALL VENDORS MUST HAVE A CURRENT PA SALES TAX LICENSE (Permanent or Temporary.) YOU CANNOT BE ACCEPTED WITHOUT A VALID LICENSE NUMBER.
5. Insurance or waiver (signed application) must be provided by vendors. York City assumes no liability for any accidents to property or person. The certificate must name City of York as an additional insured party.
