- 4. Names of all vendors will be forwarded to the Pennsylvania Department of Revenue. ALL VENDORS MUST HAVE A CURRENT PA SALES TAX LICENSE (Permanent or Temporary). YOU CANNOT BE ACCEPTED WITHOUT A VALID LICENSE NUMBER.
- 5. Insurance or waiver (signed application) must be provided by vendors. York Bike Night assumes no liability for any accidents to property or person. The certificate must name City of York as an additional insured party.
- 6. The Harley-Davidson logo is a registered trademark and cannot be used/reproduced without approval from Harley-Davidson.
