**AN ORDINANCE** 

Amending Article 121 "Administration Generally" Subsection 121.03 "Department Heads" of the City of York Codified Ordinances to established that no individual may serve as acting department head for more than 12 months during a Mayor's term of office unless approved with the advice and consent of Council.

BE IT ORDAINED, by the Council of the City of York, Pennsylvania, that Council hereby amends Article 121 "Administration Generally," subsection 121.03(b) as follows:

SECTION ONE: That Article 121, subsection 121.03(b) of the City of York Codified Ordinances is hereby amended as follows:

#### 121.03 DEPARTMENT HEADS.

- (a) Each of the Departments of the Mayor's Administration shall be headed by a Director. The Police Department shall be headed by a Police Commissioner or Chief of Police, at the discretion of the Mayor. The Fire Department shall be headed by a Fire Chief.
- (b) Each department head shall be appointed as provided in Section 123.04(d). A department head need not reside within the City at the time of an appointment by the Mayor, but shall within 120 days following his appointment, become a resident of the City and during the tenure of office shall reside within the City unless Council, by resolution, states otherwise. Each department head shall serve, subject to removal at the pleasure of the Mayor, during the term of office of the Mayor appointing the department head and until a successor is appointed and qualifies. Except for those employees under the Civil Service of the City, a department head may appoint, and with the approval of the Mayor, suspend or remove subordinate officers and employees within a department. In the case of a vacancy in the office of a department head, the Mayor may head one or more departments, temperarily for a period not exceeding 12 month unless approved with the advice and consent of Council, and have all of the powers and perform all of the duties of such department head or heads, until such vacancy is filled.
- (c) <u>Compensation of Department Heads:</u> Upon this subsection taking effect, the department heads shall receive the same percentage of a cost of living increase approved by the Council for full-time, non-affiliated City employees in the annual City budget. Any additional salary increase or bonus or other change in salary proposed by the Mayor for department heads shall only take effect by approval of Council. (Ord. 5-2008. Passed 2-19-08.)
- (d) The Mayor may appoint an acting department head for a time period not to exceed 12 months unless the appointment of such acting department head has been subject to the advice and consent of Council. No individual may serve as an acting department head for more than 12 months during a Mayor's term of office unless approved with the advice and consent of Council.

# Council of the City of York, PA Session 2019 Bill No. 20 Ordinance No.19

AN ORDINANCE

Amending Article 718 "Marijuana Possession" of the City of York Codified Ordinances to define marijuana paraphernalia and personal possession.

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of York, Pennsylvania, that Article 718 "Marijuana Possession" of the City of York Codified Ordinances is hereby amended as follows:

### 718.01 DEFINITIONS.

- a. "Marijuana" or "Marihuana" means all form of/or varieties of the genus Cannabis Sativa L., whether growing or not, as defined by Pennsylvania's "Controlled Substance, Drug, Device and Cosmetics Act" as set forth at 35 Pa.C.S.A. §§780-101, et seq.
- b. "Marijuana Paraphernalia" means any device, instrument, apparatus, or object used, intended to be used, or designed to be used for introducing marijuana into the human body or for storing containing, concealing, or transporting marijuana.
- c. "Personal Possession" means actual physical custody of or ability to exercise control over or have access to, for the purpose of one's own personal use. The term "Personal Possession" does not include possession with intent to deliver, distribute, transfer, or sell.
- **b.** <u>d.</u> "Public Space" means a street, park, sidewalk, a vehicle in or upon any street, alley, park or parking area, or any other place to which the public is invited.
- e. e. "Small amount of Marijuana" means 30 grams or less of Marijuana or 8 grams or less of hashish as set forth in 35 Pa.C.S.A. §780-113(a)(31).
- **d-f.** "Smoking" means inhaling, exhaling, burning or carrying any lighted cigar, cigarette, pipe or other such device which contains marijuana. "Smoking" includes devices designed to vaporize marijuana or marijuana extracts.

# 718.02 POSSESSION OR SMOKING OF A SMALL AMOUNT OF MARIJUANA.

- a. So long as marijuana shall be listed as a controlled substance in "The Controlled Substance, Drug, Device and Cosmetic Act," 1972, April 14, P.L. 233, No. 64, § 1 et seq., 35 P.S. § 780-101 et seq., no person shall be in possession of a small amount of marijuana as defined in said act.
  - b. The following shall be a civil violation of this Section:
    - (1) Possessing a small amount of marijuana.
    - (2) Smoking a small amount of marijuana in any public space.

- c. Persons who are found in violation of this Section shall be issued a Notice of Violation by the police or other authorized law enforcement officer. Alternatively, the officer can obtain the subject's name and address and later send the citation by First Class mail, in accordance with the Pennsylvania Rules of Criminal Procedure. a Notice of Violation by First Class Mail.
  - d. This ordinance only applies to persons eighteen (18) years old and over.

## 718.03 PERSONAL POSSESSION OF MARIJUANA PARAPHERNALIA.

- a. So long as drug paraphernalia includes objects used in connection with marijuana possession of use in the "Controlled Substance, Drug, Device, and Cosmetic Act," 1972, April 14, P.L. 233, No. 64, 1 et seg., 35 Pa.C.S.A. 780-101 et seg., no person shall be in possession of marijuana paraphernalia.
- b. It shall be a violation of this Section of this Ordinance to be in personal possession of marijuana paraphernalia.
- c. Any person who is found in violation of this Section of this Ordinance shall be issued a non-traffic summary citation by the police officer or other authorized law enforcement officer or, alternatively, the officer can obtain the subject's name and address and later send the citation by First Class mail, in accordance with the Pennsylvania Rules of Criminal Procedure.

## 718.034 ENFORCEMENT.

- (1) A Notice of Violation issued under this Article 918, shall be enforced in accordance with the procedures established by the Police Department for enforcement of summary violations.
- (2) This Ordinance shall not be construed to supersede any existing Pennsylvania or Federal law. York City police officers retain the authority to enforce any applicable laws and it is Council's intent that police officers may undertake custodial arrests where there is probable cause to believe that a criminal offense other than simple possession of a small amount of marijuana has been or is being committed.

#### 718.99 PENALTIES.

- (1) The penalty for a violation of subsection 718.02(b)(1) and 718.03(b) of this Section by an adult shall be a civil fine of one hundred dollars (\$100.00) for a first offense; two hundred fifty dollars (\$250.00) for a second offence; and five hundred dollars (\$500.00) for a third offense in a five year span. Any subsequent offense over third offense in a five-year span will fall outside of this ordinance and shall be charged in accordance with Federal and Pennsylvania law. The court may in its discretion suspend the fine imposed under this subsection 918.02(b)(1) for a first offense if the person found liable agrees to and does in fact perform such community service as the court deems appropriate, up to nine hours.
- (2) The penalty for a violation of subsection (2)(b) shall be a civil fine of one hundred fifty dollars (\$150.00) for a first offense; three hundred dollars (\$300.00) for a second offense; and six hundred dollars for a third offense. The court may in its discretion suspend the fine

#### AN ORDINANCE

Amending Article 933 "Sewer Rentals" and 951 "Municipal Solid Waste Management Act" of the City of York Codified Ordinances to establish language for collection of past due sewer rental and refuse fees.

WHEREAS, the City of York charges fees for providing sewer rentals and refuse collection; and

WHEREAS, the City has historically struggled with effectively collecting past due sewer rental and refuse fees; and

WHEREAS, in an effort to more effectively collect past due sewer and refuse accounts, and to come in line with best practices exercised by other providers of utility services, the City needs to redefine when a past due account is considered to be "delinquent";

NOW, THEREFORE, BE IT ORDAINED, by the Council of the City of York, Pennsylvania, that Council hereby amends Article 933 "Sewer Rentals" and Article 951 "Municipal Solid Waste Management Act" of the City of York Codified Ordinances as follows:

SECTION ONE: That Article 933, Section 933.09 of the Codified Ordinances is hereby amended as follows:

#### 933.09 DELINQUENT SEWER RENTALS AND LIENS.

(A) All sewer rentals, together with all penalties and fees thereon, that are past due for a period of 30 days not paid on or before the end of six months from the beginning of each billing period shall be deemed delinquent for the purposes of this article. All delinquent sewer rentals and all penalties and fees thereon shall be a lien on the property served and shall be entered as a lien against such property in the Office of the Prothonotary of York County and shall be collected in the manner provided by law for the filing and collection of municipal claims. Any and all costs associated with recovering delinquent sewer rentals, whether those costs are incurred by the City, or by a Third Party. are recoverable by the City or a Third Party contracted with the City to recover delinquent sewer rentals. The City may also request water service termination in accordance with applicable State laws to provide for the collection of delinquent accounts.

SECTION TWO: That Article 951, Section 951.14 of the Codified Ordinances is hereby amended as follows:

#### 951.14 DELINQUENT COLLECTION FEES AND LIENS.

All refuse collection service fees, together with all penalties thereon, that are past due for a period of 30 days not paid on or before the end of six months from the beginning of each billing period shall be deemed to be delinquent for the purpose of this article. All delinquent refuse collection service fees and penalties thereon shall be a lien on the property served and shall be entered as a lien against such property in the Office of the Prothonotary of York County and shall be collected in the manner provided by law for the filing and collection of municipal claims. Any and all costs associated with recovering delinquent refuse collection service fees, whether those costs are incurred by the City, or by a Third Party, are recoverable by the City or a Third Party contracted with the City to recover delinquent refuse collection service fees.

SECTION THREE: This ordinance shall become effective in accordance with the law.

**A RESOLUTION** 

Authorizing a Contract Agreement between the City of York Bureau of Health and the York County Planning Commission's Housing Division, to administer and deliver the City's Lead-Based Paint Hazard Control and Healthy Homes Grant Program.

WHEREAS, the City of York has been recognized and awarded grant funding, provided by the U.S. Department of Housing and Urban Development (HUD), through the Pennsylvania Department of Health; Bureau of Family Health to provide Lead-Based Paint Hazard Control and Healthy Homes remediation throughout the City of York; and

WHEREAS, the City of York's Bureau of Health has implemented a Lead Hazard Control and Healthy Homes Grant Program to address lead hazards and remedy key issues in homes that affect the health and safety of low-to-moderate income families, including those with children under the age of six, that have been identified to have elevated blood levels; and

WHEREAS, the City of York's Bureau of Health has recognized a need for assistance in the administration of the Grant Program; and

WHEREAS, the Housing Division of the York County Planning Commission has Lead-Based Paint Hazard Control and Healthy Homes trained and certified staff that is able to assist in the administration of the Program; and

WHEREAS, the City of York Bureau of Health and the County of York, on behalf of the York County Planning Commission entered into an Agreement to provide assistance with the implementation and administration of the City's program, effective July 1, 2017 through June 30, 2019.
