CALL TO ORDER: President Nixon called the November 19, 2019 public hearing to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: H. Michael Buckingham, Edquina Washington, Judy A. Ritter-Dickson, Sandie Walker, Vice President, and Henry Hay Nixon, President, with President Nixon presiding.

I. **PUBLIC HEARING – 6:00 PM**

President Nixon called to order the November 19, 2019 public hearing to receive testimony on the request made by York Building Products for approval of a CONDITIONAL USE application to demolish an existing asphalt plant on the adjoining property (parcel ID 14503140001000000) near Roosevelt Avenue and to construct a new asphalt plant.

The York City Planning Commission and Zoning Officer have determined that the Zoning Ordinance (§1304.1-6.02.003) defines this use as Hazardous Industrial and allows this use by CONDITIONAL USE permit, which the applicant has applied for.

This hearing is being held in accordance with Section 1311.13 of the City's Planning & Zoning Code. Council will consider approval of the request this evening. (See agenda item #8)

Craig Sharnetzka, CGA Law Firm, stated that he is here on behalf of York Building Products as well as Jim Gawthrop, Vice President, Aggregate Division, York Building Products,

Mr. Sharnetzka outlined the application for a conditional use. A copy of the application is attached to <u>Resolution</u> <u>No. 105 of 2019</u> located in the City Clerk's archives. Mr. Sharnetzga then answered questions from Council.

A copy of the transcripts of this hearing was completed by York Stenographic Services, 34 N. George St., York, PA, and will remain on file at their facility for a period of five (5) years.

There being no further business, the public hearing adjourned at 6:22 p.m.
