CALL TO ORDER: Vice President Walker called the September 21, 2021 meeting to order at 6:00 PM in City Council Chambers with the following members present: Lou Rivera, Edquina Washington, Judy A. Ritter-Dickson, and Sandie Walker, Vice President, with Vice President Walker presiding.

I. Special Presentation:

2022 George Street Resurfacing Project - Jeff Shue, C.S. Davidson, stated that the project is scheduled to begin in the Spring of 2022. The project will include base repair, resurfacing from Rathon Rd. to North St., signal upgrades, thermoplasma pavement markings, and additional ADA compliant pedestrian walking along George St. He said we will continue to have 2-way traffic on George St. throughout the entire project. They hope to have the project completed prior to fall of 2022. They will start with concrete work, storm sewer upgrades, milling, and pavement markings. YAMPO is charged with allocating federal dollars that will come through PennDot. The project is estamiated at \$2.6 million with federal dollars totaling \$3.1 million. Bid were received through PennDot's ECMS program since this is federal dollars. The second part to this project is currently being designed and will take milling and paving into North York, including renovations to Codorus St. bridge. Mr. Shue said Council will be asked to pass a resolution that allows this money to come through the city and to check a box that tells PennDot that we explained this project in a public setting.
