# Case #1 – 130 E Market St

A request by Goldfein & Joseph, P.C. to replace damaged windows.

# DISCUSSION

Mr. Scott Fleischman of Goldfein & Joseph, P.C and Mr. Robin Ness of Lauer Construction summarized the proposal. The center fourth-story window has been damaged. The application proposes to replace the fourth-story windows with wooden reconstructions, likely of Spanish cedar. Mr. Shermeyer noted that the proposal is essentially replacement in-kind.

# ACTION

Mr. Shermeyer moved to recommend approval of the proposal as submitted. Mr. Skehan seconded. The motion carried unanimously.

#### Case #2 – 48 E Market St

A presentation by the York County Industrial Development Authority for preliminary feedback on proposed signage.

#### DISCUSSION

Ms. Kristin Topper with JMT, consulting engineer on the project, and Mr. Jack Kay, Chair of the YCIDA, summarized the portfolio of signage proposed. Mr. Kay stated that the signage has three goals: wayfinding, meeting the requirements of the Hilton brand and meeting the requirements of the National Park Service, as this is a historic tax credit project subject to NPS approval.

The Board agreed, generally, with the proposed work. As stated in the staff review, Mr. Skehan and Mr. Shermeyer noted that internally-lit signage, as proposed for the canopy sign, is inappropriate in the historic district per the York Design Guidelines. The Board noted its preference for "halo-lit" letter signage.

Ms. Robbins also indicated concerns with the large size of the proposed vertical sign on the southern elevation.

#### ACTION

Mr. Kay reiterated that this presentation was preliminary and the applicant did not seek a final recommendation to Council at this time. YCIDA/JMT will return with a more detailed proposal at a later date.

#### **Other business**

Ms. Alicia O'Rorey of First Presbyterian Church discussed with the Board the process and possibilities for repairing and replacing the front steps of the Billmeyer House. Ms. O'Rorey will return with a more detailed proposal at a later date.

#### Adjournment and next meeting

Mr. Kunkle adjourned the meeting at approximately 6:45 PM. The next meeting is scheduled for December 9, 2021.
