- 3. Please explain why Council does not have faith in the York organizations proposed in the 2022 budget as stated at the December meeting.
- 4. If funds are not distributed as recommended, how will that money be used? If funds are distributed, who will decide who gets funded?
- 5. On Jan. 1, it was stated that Council will use a qualified professional to administer the funds. What does that mean specifically?
- 6. Council has stated that they will present a plan to the mayor and may need a mediator. Why? What changes have been made to the proposed funding and who made them? And if a mediator is needed who be the mediator?
- 7. A second round of grant applications and funding was planned. Will that happen? Why or Why not?
- 8. Simply put, please explain the who's, what's, when's, where, and how's of City Council reaching this point in the ARPA funding process and the who, what, when, where, why, and how that will be used for the situation to be resolved and the funding distributed.

- XII. Council Comment:

President Walker the following statement:

"Without beating a dead horse, we must understand that ARPA funds were meant to help municipalities recover from the negative impacts of this pandemic first. Though one of the over 60 expense categories could be used to assist non-profit organizations, there needed to be a plan and

framework in place as a guide for how the entire \$35.3 million dollars would be spent before taking action. We also must understand that as a municipal entity, the City of York was not eligible for federal assistance that non-profits and businesses were eligible for such as the EDIL and forgivable PPP loans that have been supporting our businesses and non-profits throughout the pandemic. Simply put, there needed to be some type of strategic plan for the City of York and its operations, businesses, and nonprofit organizations before taking action. This was the concern from the beginning. The Mayor made it clear that he did all that he was going to do. Since there was not a plan in place, City Council had to create one. The approximately 26-page recovery plan recommendation is directly aligned with the final interim rules and regulations issued on January 6, 2022. These final interim regulations give the City of York even more flexibility and discretion in the use of these once-in-a-lifetime funds. Waiting for these final regulations allowing increased fund flexibility is another reason why we were concerned with the rush to distribute the funds. By waiting a few more weeks for the final rule, we can make even better decisions now and for the future. In this recovery recommendation plan, you will find an executive summary, expense categories, and use of funds to include initiatives such as our proposed \$2,500 essential worker bonus and over \$8 million dollars in assistance to homeowners, senior citizens, residents on fixed income, veterans, small businesses, and nonprofit organizations.

One of the things that I've learned over the years as a locally elected official is that there often are gray areas between societal matters and government matters. Locally elected officials have to navigate that area on a continual basis. In this case, we had to base recommendations off of initiatives that will ease burdens of our residents now and in years to come. We appreciate all of the work that has been done, especially by those who volunteered within our community. Your work is recognized and even highlighted in this plan. We believe these funds are part of the strategic foundation that will help lay the framework for a Better York going forward."
