AN ORDINANCE

Amending the FY2022 City Budget as follows: (1) York City Fire Department to fund Rex/Laurel Fire Station Renovations by appropriating expenditures from the American Rescue Plan Act "ARPA" funds, in the amount of \$750,000.00; (2) Community & Economic Development to fund Penn Street Market Renovations by appropriating revenue and expenditures from ARPA funds, in the amount of \$750,000.00.

**WHEREAS**, the received American Rescue Plan Act "ARPA" funding in fiscal year 2021 and amended the City of York 2021 budget to show the incoming revenue in account 29-200-34166-00000; and

**WHEREAS**, amendments have been requested to the FY2022 City Budget;

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the City of York, Pennsylvania, that the FY2022 York City Budget is hereby amended as follows:

**SECTION ONE:** Amending the fiscal year 2022 City Budget for the York City Fire Department to fund Rex Laurel Fire Station Renovations by appropriating expenditures from the American Rescue Plan Act "ARPA" funds, in the amount \$750,000.00 as follows:
