AN ORDINANCE

Amending the FY2022 City Budget for York City Police Department to fund a Police Cadet Program, GVI/Credible Messengers, a second GVI Street Team, the Shotspotter/Trauma Informed Care Program, Small Unmanned Aircraft System (sUAS) Program, Building Rehab/Reprogram York Initiative, Tele-Policing Program, and a Victim Notification/Follow-Up/Officer Satisfaction Program by appropriating expenditures from the American Rescue Plan Act "ARPA" funds in the amount of \$2,702,641.83.

**WHEREAS**, the city received American Rescue Plan Act "ARPA" funding in fiscal year 2021 and amended the City of York 2021 budget to show the incoming revenue in account 29-200-34166-00000; and

**WHEREAS**, amendments have been requested to the FY2022 City Budget;

**NOW, THEREFORE, BE IT ORDAINED**, by the Council of the City of York, Pennsylvania, that the FY2022 York City Budget is hereby amended in accordance with the following schedule:
