MINUTES **March 1, 2022** 6:00 p.m.

CALL TO ORDER: President Walker called the March 1, 2022, meeting to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: Dr. Felicia O. A. Dennis, Betsy Buckingham, Edquina Washington, Vice President, and Sandie Walker, President, with President Walker presiding.

Members of the Administration in attendance included: Michael Helfrich, Mayor; Kim Robertson, Acting Business Administrator; Melanie Baldwin, Grants; Nona Watson, Director of Economic & Community Development; William Sleeger, Fire Chief; Michael Muldrow, Police Commissioner; and Jason Sabol, Assistant Solicitor.

Members of York City Council staff in attendance included: Dianna L. Thompson, City Clerk.

I. Public Comment:

Chastity Frederick, resident, and York City Bureau of Health employee stated there are currently 24 open positions for the City of York with most of those positions having to meet the city's residency requirement. She discussed the pros and cons of living within boundaries. She asked for a response from the Council on addressing the constraints of the city's residency requirement and said let's work together.

Don Hake, resident, spoke about the Leadership Energy Environmental Design (LEED) certification and asked that said certification be required on all new and residential construction in York City. He also asked Council to consider legislation switching to electric vehicles, and to outlaw the use of Styrofoam containers and plastic straws because they are not recyclable. He also asked that a position be created that focuses on the environmental aspects of our city. He said he has asked for environmental positions to be created in the past, but his calls and emails have gone unanswered.

Police Commissioner Michael Muldrow thanked Council and the Administration for their support in considering this funding and allowing us to put a package in front of you that will help our families and kids. He also thanked all residents, family, and friends that showed up tonight to support this initiative.

Matt Enright, York Dispatch, asked if this program is approved, how much ARPA money will be left for the city; I know the combined total is \$35.3M. He asked what the small, unmanned aircraft will be used for?

Mayor Helfrich responded that a ballpark figure is that we've allocated about \$5 million dollars of the \$35.3M ARPA funding. He then explained that the small, unmanned aircraft will be used in the Fire and Police Departments. He said this aircraft would patrol the illegal dirt bikes ravaging our streets, will help to find lost children, or even illegal items that may have been tossed onto a rooftop. For the Fire Department, he said being able to see what's going on from above instead of risking our firefighters is a huge benefit.

Carol Hill-Evans, resident, said these are all wonderful programs and asked if this is the same \$5M that the ARPA committee discussed when making its recommendations.

Mayor Helfrich said most of the items he and Council have agreed upon so far were from the recommendations of the ARPA committee. He said he'll continue to advocate for the community.

President Walker said we're working off the recommendation plan of Council and we've had meetings with the Mayor and department heads to discuss items for consideration of ARPA funding. This will also include an ARPA grant manager and contractor to help us with this process. She said the funding recommendations for the non-profits are not being thrown away. We will review those in our OpenGov procurement program. She said we have to make sure the funding is within the rules and requirements, and we didn't want to give a sense of false hope to organizations that applied for funding.

Carol Hill-Evans, resident, asked if there will be another advisory committee.

President Walker an advisory committee is not part of Council's recommendations.

Manuel Gomez, resident, said 14 years ago ShotSpotter was purchased for the city but the data was not reliable. They now say the ShotSpotter has been upgraded. If you Google ShotSpotter, you'll see how unreliable this system is. They are being sued because of their unreliability. Most of the alerts were false. We have to be careful how we deploy technology. We still had to pay them hundreds of thousands of dollars per year for this shotty system. He said we need sustainability and to figure out how we're going to afford these costs. Mr. Gomez stated that he hasn't seen any feedback from the community on whether the unmanned aircraft systems – also referred to as drones – are relevant or if this technology even fits in our community. He said we should have a dialogue on these issues and that he opposes the use of ShotSpotter and drones.

Melissa Rasario, resident, asked what confidence do we have that what happened in Chicago won't happen in York when using the ShotSpotter system.

Mayor Helfrich said the old ShotSpotter was trash and their representatives spent a long time explaining to all of us the things that have been changed to make it better. He briefly explained how ShotSpotter works. He said he and Police Commissioner Muldrow were skeptical, but they feel assured that this system will work when coupled with the trauma outreach program. This way

we can deploy trauma counselors into the neighborhoods and schools to check on them to be sure they are okay. He said the best way to make our police officers better is with support tools such as this. If we make a mistake, he said we can end this process.

Commissioner Muldrow said this will be a year-to-year contract and we're looking for grant funding for future years. He said no disrespect toward Chicago, but his kids are dying here in York. He stated that he gets calls from our residents when their family members are dying. He said he's trying to identify traumatized neighborhoods and speak to the kids and families who are affected by these traumatic experiences.

Motion to amend: President Walker said she appreciates the comments and concerns brought up this evening and that clearly more discussion needs to be had. As such, President Walker made a motion to amend Bill No. 9 to remove funding for ShotSpotter and the unmanned aircraft as follows:

Reduce line item 29-500-44400-00424 Other Contractual Service from \$292,000.00 to \$92,000 Reduce line item 29-500-46170-00402 Other Capital Equipment from \$40,000.00 to \$0 Reduce the total amount of all expenditures from \$2,702,641.83 to \$2,335,641.83

The motion to amend was seconded by Washington and came up for discussion.

Aaron Anderson, resident, said it seems hasty to pull those items from the budget at this point based on a couple of questions. He said he thinks it's due time for us to have an effective civil rights policy in place but said he feels you can approve this item and task some group to work on these issues. He asked that we trust our Police Commissioner so he can continue to deal with some problems that are very pressing for our community.

Manuel Gomez, resident, said if we had more data to inform ourselves, then we would speak of such data at that point, but we don't have that data. If you would create the space for dialogue, we may be more inclined to work on these initiatives, tentatively. He said institute it in the pilot phase and let's see how we can balance this initiative.

Commissioner Muldrow said he likes Mr. Gomez's idea and appreciates his feedback. He asked Mr. Gomez to contact him about the drone policy.

Tanoa Sweeney, resident, asked how are we going to have a pilot program if there is no funding?

Commissioner responded that there will be no pilot program if funding is removed.

Ms. Sweeney said to remove funding because of one comment seems unfair. She said these dirt bikes are a problem and will get worse as the weather warms up.

Mayor Helfrich said we will come back to Council with these recommendations, so this isn't the end of the road because he plans to introduce these items again.

Margaret Eckles-Ray, resident, said when we are discussing matters of our community, we can find data to support the pros and cons. It would have been better if we would have agreed to disagree and move into the development phase that some of us were looking forward to. She said she found articles as recent as two weeks ago that spoke about the pros and cons to the ShotSpotter initiative. She stated that she hopes when this is re-introduced, we can agree that there isn't a perfect answer and move toward what works.

Manuel Gomez, resident, said he's looking forward to dialogue on how to move our community forward.

President Walker thanked everyone for their comments and stated that we're looking forward to more discussion.

Vote on motion to amend. The motion to amend passed by the following vote: Yeas - Dennis, Washington, Walker - 3; Nays: Buckingham - 1. The motion to amend was approved.

Assistant Solicitor Sabol said Rule 6(B) and 6(B)(2) are not feasible. He said in Rule 6(B) to expect the solicitor's office to review items and forward to the City Clerk the day after the deadline is not enough time for proper review, and Rule 6(B)(2) Council can't automatically place an item on the agenda if the item hasn't been reviewed by the solicitor's office.

Manuel Gomez, resident, said he has always been a harsh critic of the solicitor's office, but he agrees that 24 hours turnaround time would place too much of a strain on the solicitor's plate. He suggested Council get its own attorney.

Mayor Helfrich said he agrees that Council should have their own attorney as well. He said the current system is an unreasonable way to function. He said he would be happy to have Human Resources work on this with Council. He too agreed that Rule 6(B)(2) which would authorize items to be placed on the agenda if the solicitor's office doesn't respond to agenda item submissions is unreasonable. Plus, he said the solicitor's office is in court on Wednesday's and doesn't have the time to review agenda items on that day.

Motion to amend. A motion was made by Buckingham to amend Rule 6(B) to require the solicitor's office to submit items its reviewed for the agenda to the City Clerk by 10AM on the Friday before the scheduled Council meeting and to remove all of Rule 6(B)(2).

Assistant Solicitor Sabol said he's in agreement with the proposed amendments.
