CALL TO ORDER: President Walker called the April 19, 2022, meeting to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: Dr. Felicia O. A. Dennis, Betsy Buckingham, Lou Rivera, Edquina Washington, Vice President, and Sandie Walker, President, with President Walker presiding.

Members of the Administration in attendance included: Michael Helfrich, Mayor; Kim Robertson, Acting Business Administrator; Melanie Baldwin, Grants Administration; Blanda Nace, Chief Opportunity Development Officer; and Jason Sabol, Assistant Solicitor.

Members of York City Council staff in attendance included: Dianna L. Thompson, City Clerk.

- ١. Public Comment: President Walker called the April 19, 2022 public comment session to order at 6:00 PM. As there was no public comment, President Waler adjourned the public comment session at 6:01 PM and immediately convened in legislative session.
- 11. Called Legislative Meeting to Order at 6:01 PM.
- III. Roll Call
- Pledge of Allegiance recited. IV.
- V. Moment of Silence observed.
- VI. Action on previous meeting Minutes of April 5, 2022. Council dispensed with the reading of the Minutes and approved them by the following vote: Yeas - Dennis, Buckingham, Rivera, Washington, Walker - 5; Nays - 0.
- VII. Proclamations, Awards and Announcements:

Claiborne Lofts Project - Andrew Cohen, Sr. VP-Development, will give a brief presentation on the Claiborne Lofts Project (Dentsply Office Bldg.) - an adaptive reuse rental housing for independent seniors aged 62 and over.

Mr. Cohen presented Council with a packet of information about the Dentsply Office Building. He said he met with the city's Economic Development employees about a year ago when the property was first on the market. The property was eventually pulled off the market but is now again up for sale. He said the deadline is May 6 to make an offer on the property. He explained that 550-570 W. College Ave. are the properties his firm, Woda Cooper, is interested in to convert into 50-60 units of independent, senior affordable housing. The other building is the manufacturing plant and Yohn Properties is interested in that building with plans to do about 60+ market rate general occupancy housing units. The buildings are in good condition ready for adaptive reuse. He said the impediments are site control and rezoning, and they are available to work with city officials if they acquire the property. He stated that Dentsply wants to sell to the highest bidder, and they are not interested in selling their property in pieces. He said city should consider the future of this property. It would be a tragedy if the city doesn't step up and take control of what happens to this property, he said.

Councilman Rivera asked if Dentsply doesn't want to sell its property in pieces, what's the city supposed to do?

Blanda said everything east of Grantley is an opportunity zone. Dentsply hasn't given us an asking price. We have an idea of what it should go for. The property is listed with Wishman-Goodfield. The RDA submitted a letter of intent last year and our purchase price was for them to donate it to us. Blanda said the market rate is about \$3-5 million for the property.

Betsy asked what happens if no offers are received by May 6.

Cohen said they would sign a contract today for \$750,000 if they can get through all the red tape.

Blanda Nace, the city's Chief Opportunity Development Officer, said we are in a housing crisis nationwide but in reality, this is a 1909 building.

Mayor Helfrich said we have to decide if we want to use ARPA money to purchase this building, but this has to occur within the next 3 days if we are to determine what moves need to be made. He said it would behoove the city to take control of this property but we're looking at a tight situation and would have to work miracles. If Council wants to discuss this over the next 72 hours, he said we would have to have Council approve about \$3 million to move forward.

Vice President Washington said if this property were to be acquired by the city's Redevelopment Authority, it's imperative that we look at affordable housing and programs to assist homelessness. There is a lack of affordable housing in the City of York so if we could be creative and innovative in using the property to meet the needs of our community, that would be preferred, she said.

Mayor Helfrich said if Council were to participate, we would determine what the property would be used for.

Councilwoman Dennis asked if we owned the property, we could demand what happens and that we should focus on the goal of affordable housing because sometimes the goal shifts.

Mayor Helfrich asked Council to think about it over the next 12-24 hours if they want to use ARPA money to acquire the Dentsply property.

President Walker asked how long discussions have been going on about using ARPA funding for this purchase.

Mr. Nace responded just within the past 20 minutes.

Mayor Helfrich said we really have no idea what the cost would be for the property. We're just throwing numbers out there.

Councilwoman Dennis said Melanie Baldwin, the city's Grants Administration, needs to be involved in any discussions about using ARPA money for acquisition of properties.

Councilwoman Buckingham asked about the tax implications.

Mr. Nace said LERTA, RETAP or some type of rebate program could be considered.

Mayor Helfrich said mercantile tax is lost with Dentsply leaving the property, which is a financial blow to the city.

There being no further discussion, the presentation concluded. Further discussion on this topic is suggested to take place at Council's April 27<sup>th</sup> committee meeting.
