CALL TO ORDER: President Walker called the April 5, 2022, meeting to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: Dr. Felicia O. A. Dennis, Betsy Buckingham, Lou Rivera, Edquina Washington, Vice President, and Sandie Walker, President, with President Walker presiding.

Members of the Administration in attendance included: Michael Helfrich, Mayor; Kim Robertson, Acting Business Administrator; Melanie Baldwin, Grants Administration; and Jason Sabol, Assistant Solicitor.

Members of York City Council staff in attendance included: Dianna L. Thompson, City Clerk.

Ι. **Public Comment:**

Ryan Supler announced that the next Avenues Neighborhood Association (ANA) meeting will be held on April 18, 2022, at 5:30 PM at the York Ice Arena. For more information on ANA visit: www.anayork.webs.com. He then gave an update about the CODE Blue Emergency Shelter Program. Lastly, he said the Election's Office is looking for volunteers to help out during the elections. For more information, call (717) 771-9604.

Charlene Belcher spoke about the Shotspotter program. She said she lives in Dover, but her mom lives in the city and her and her family frequents the city of York. She said she understands the concerns about the Shotspotter program especially the problems with the system in Chicago. She said an Edgewater Analytics Report is available and gives good information on how accurate the Shotspotter is. She said Cooper Hospital, which is a level 1 hospital, aligned with the Shotspotter program. Over the course of a year, she said they were able to track qunshots which shaved 4 minutes off of calls which is significant when considering saving lives. Ms. Belcher also stated that the City of Oakland, CA, has good information on how they use Shotspotter and drones. They are required to turn in a yearly report that is made available to the public so they can continue receiving funding.

Sasha Kaufhold stated that she was picking up her child on the day the young man was shot and killed on Penn Park. The school was on lockdown because of it. She said police activity was present, kids were crying, and a body laid on the ground. She said she is scared her child will catch a bullet during recess. She said the emotional toll of seeing that dead body was traumatizing. She thought about moving to York City but after seeing what she saw, she said she's thinking twice about putting down roots here because of the violence. She said she wants to protect her children and her legacy. She encouraged Council to think about their vision for the city in the years to come and what small steps can be taken now toward that vision.

Joyce Santiago, Executive Director, Affordable Housing Advocates, said we are here to ensure affordable housing. She said she appreciates the recognition of Fair Housing Month.

Jose Santiago, YMCA, said this is important because housing is critical at this moment and as providers, we need to work together to correct the wrongs in housing.

Terry Abruzzese, & Natasha Kukorlo, York Habitat for Humanity, said a lot of people are living in their cars because of the housing crisis and that they build safe, affordable housing for residents. They are currently revitalizing the 700 block of W. Chestnut St. and they are still accepting applications for Habitat Homes. They then outlined the qualifications to receive a Habitat home.

Mina Edmonson, YCHRC Commissioner, invited all to a Fair housing Clinic on April 25 from 10-6pm in Council Chambers to learn more about fair housing. She said they will have speakers and information tables set up.

Selena Schriver said they live next to this property and were displaced from the only place they've called home because they were instructed by city officials to evacuate their property. Ms. Schriver stated that she, her family, and her emotional support dog took one final glance of their home before they loaded all of their belongings into their car. She said they begged and pleaded with relatives for a place to stay to no avail. She said they were provided with emergency contacts but none of them could help them. Ms. Schriver said some of them wanted to split up her family and send her dog to the SPCA. She said she could not do that. Right now, Ms. Schriver stated that they are staying at a hotel until Monday. After that, they don't know where they will go and will probably end up in their vehicle. She said they don't have enough money to stay for another week in a hotel. She asked that the property come down soon so they can go back home.

President Walker said those who are here today that spoke about fair housing might be able to help. She said although Council is not able to assist, we empathize with your situation. She asked that Ms. Schriver stick around after the meeting and speak with them.

Stephanie Seaton, YCHRC Chair, said they have spoken with Mr. Schriver and there has been expediency on addressing this, but she understands that it doesn't seem like it because of the critical nature of their situation. She said this is critical and we will work with Ms. Schriver.

Joyce Santiago, Executive Director, Affordable Housing Advocates, asked if the city's HOME funds can help with housing. She said we have to do better as a community to address these housing issues.

Mayor Helfrich said he's not sure because he believes those dollars are allocated based on HUD rules. He said this is not a property owned by the city - we are demolishing a safety hazard.

There being no further discussion, Resolution No. 48 passed by the following vote: Yeas - Dennis, Buckingham, Rivera, Washington, Walker - 5; Nays - 0.
