- Being in the middle of a housing crisis, majority of cases coming in are Housing related.
- We need to do outreach and let people know that we are here and not only for Housing or Landlord/Tenant issues but for employment and Public Accommodation issues as well.
- Will get in touch with PHRC to try to get a "Shadowing" day from them to just oversee or staff. We want them to be as equipped as they can.

### New business:

## • Commissioner Richardson:

- Finding out a way that can make Council City mtgs more accessible to the public. People were being a bigger part of mtgs when Covid because of mtgs being through zoom and they felt freer to comment. Now Mtgs have been reopened to the public, therefore, and numbers of people coming in the mtgs have dropped. Having inperson mtgs along with virtual meetings, giving people accessible avenues for them to choose from and comment. "Lets not forget, our city residents *are* County residents as well and should be approached."
- As far as languages go, it would be in the best interest of the Ordinance if we could get a translation service for our events. Lou Rivera would be our best approach for these two topics (meeting will be requested).
- Commissioner Seaton: Reaching out to HUD for substantial equivalency to get our FHAP grant back.
