Case #1 - 31 S Queen St.

Teresa Johnescu has submitted an application to replace front door.

Discussion:

Original door to be replaced with mahogany, replacement in-kind.

ACTION:

Mr. Skehan moved to recommend approval as presented and Mr. Buffington seconded. The motion carried unanimously.

Case #2 - 231 S Beaver St.

Don Portner has submitted an application to replace 13 double hung windows and storm doors.

Discussion:

Windows to be replaced in-kind with Marvin windows with grids to match original. Any stain glass windows will remain. Replace storm door to match original. Retaining frames and all woodwork remaining.

ACTION:

Mr. Shermeyer moved to recommend approval as presented and Mr. Buffington seconded. The motion carried unanimously.

Case#3 - 466 E Market St.

Darren Kinnard has submitted an application to replace existing neon canopy sign with new 19'x 60" sign.

Discussion:

Replacing existing sign on original bracket. Only changing message. Sign is facing east Market Street traffic.

ACTION:

Mr. Skehan moved to recommend approval as presented and Mr. Kunkle seconded. The motion carried unanimously.

Case#4 – 108 S Pershing Ave.

Michael Doweary has submitted an application to replace gutter and downspout and install new soffit and fascia.

Discussion:

Replace existing rotted wood members and metal flashing and gutter. Will use composite wood, or epoxy (consolidant) where needed.
