**Thank you for your interest in working with the York City Redevelopment Authority. As you explore your project, here are a few important things to know:**

*Gracias por su interés en trabajar con la Autoridad de Reurbanización de la Ciudad de York. A medida que explora su proyecto, aquí hay algunas cosas importantes que debe saber:*

- **To view ANY RDA-owned structure, a liability waiver must be completed and left on file with a copy of identification for anyone entering the property. Liability waivers can be completed at the City Hall at 101 S. George Street, 2<sup>nd</sup> Floor, Dept. of Economic Development**

*Para ver CUALQUIER estructura propiedad de RDA, se debe completar una exención de responsabilidad y dejarla en el archivo con una copia de la identificación de cualquier persona que ingrese a la propiedad. Las exenciones de responsabilidad se pueden completar en el Ayuntamiento en 101 S. George Street, 2nd Floor, Dept. of Economic Development*

- **Properties must be resecured upon exit. Failure to do so may result in denial of future RDA-property views**

*Las propiedades se deben volver a asegurar a la salida. El no hacerlo puede resultar en la denegación de vistas futuras de la propiedad RDA*

- **The Minimum offer amount accepted is \$1,500.00 per parcel, however the RDA Board reserves the right to negotiate costs and fees.**

*El monto mínimo de oferta aceptado es de \$1,500.00 por paquete, sin embargo, la Junta de RDA se reserva el derecho de negociar costos y tarifas.*

- **Option agreements are granted for a 6-month period to explore potential projects, this period is called “Due Diligence.” The fee is \$500 per property, per 6-month period. The option agreement fee is non-refundable, but will be added to your total sales price should you purchase the property.**

*Los contratos de opción se otorgan por un período de 6 meses para explorar proyectos potenciales, este período se denomina “Due Diligence”. La tarifa es de \$ 500 por propiedad, por período de 6 meses. La tarifa del acuerdo de opción no es reembolsable, pero se agregará a su precio de venta total si compra la propiedad.*
