CALL TO ORDER: President Walker called the February 7, 2023, meeting to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: Felicia Dennis, Betsy Buckingham, Lou Rivera, and Sandie Walker, President, with President Walker presiding.

Members of the Administration in attendance included: Kim Robertson, Acting Business Administrator; Joe Jefcoat, Treasurer; Michael Muldrow, Police Commissioner; and Jason Sabol, Assistant Solicitor.

City Council staff in attendance: Dianna L. Thompson, City Clerk

I. Public Comment:

Tiffany Lowe, GVI (Group Violence Intervention) Project Manager, said she noticed gaps that she hopes Council can fill in. GVI is an evidence-based strategy that when working with law enforcement, crimes rates can go down. She gave statistics on the costs of crime prevention mechanisms. She said if we work together, we can find solutions to help deter crimes. GVI knocks on doors to build rapport and share information with citizens. She applauded Council for their commitment to the city and that each member must have been impacted by crime at some point in their lives. She discussed the number of crimes that have occurred in the city under Council's leadership. She asked if these number are specific enough to ask that cameras and ShotSpotter be installed. She turned around and showed the back of her t-shirt that named several individuals that have died due to gun violence. She said GVI has Credible Messenger which is a valuable tool for the GVI unit. She said if you could have saved these victims lives, you would have. She thanked Council for appointing more police officers. She also thanked Commissioner Muldrow for his work in addressing crimes. She asked Council to consider doing more and incorporate artificial intelligence into the community so we can save lives.

Councilman Rivera said Ms. Lowe is the future of our community and he applauded her for her work in the community.

Michael Walker, resident, said he was glad to have been able to attend and speak at the Better York meeting on the topic of citywide cameras. He said because of a 2005 Commonwealth Law, several municipalities have instituted citywide surveillance. He said the mayor's endorsement for the City of York could be unconstitutional. He said there are laws on who can and cannot publicly surveil. He said in the Better York meeting, he was one of three people of color in attendance. He said his credentials

and education were dismissed and resulted in a dog whistle dismissal of facts. He said if he reacted to this microaggression, the big picture would have been missed. He said after seeing this behavior and hearing this dog whistle, at the right time, he addressed the mayor only to be degraded. He asked if the powers that be can just respect all of our community beyond stereotypes. He said for those who continue to fall to inadequate stereotypes they will continues be dismissive of comments and suggestions made by members of our community. He said there is a growing coalition of diverse men and women who want to support this city, but these prejudices and biases have always presented an unwarranted roadblock.

Manuel Gomez, resident, said a lot goes on behind the scenes but if we can focus on the work that is being done, we can get further. He said he believes we get a little antagonistic how we do things but as a regular person that's here, we need to stay focused and keep the public informed.

There being no further comment, the public comment session adjourned at 6:19 p.m.

Final Passage of Bills/Resolutions

1. Final Passage of Bill No. 3, Ordinance No. 3 - A Bill

Increasing the salary of the City Treasurer. (<u>View</u>) (\$50,000 effective January 2024) Introduced by: Betsy Buckingham

Originator: Treasurer

Marilyn Hake, resident, spoke in support of increasing the Treasurer's salary. She said the Treasurer's salary has remained the same since 1996. If we want good candidates, we need to offer a salary commensurate with the responsibilities.

Teresa Johnescu, resident, also spoke in support of the Treasurer and its only fair that he receives pay that matches other city executives.

Marie Rohleder, resident, said we need Treasurer Jefcoat, and she is worried what will happen if we can't keep someone of his caliber and expertise. Increase this salary not just for Joe's sake, consider others who will become the city Treasurer down the road.

Joe Jefcoat, Treasurer, thanked those who spoke in support of his increase. He said he has attended meetings about his salary increase. He said the school district and the county are in support of an increase. He said the ordinance that is written only compensates for the collection of the real estate taxes. He read section 415 of the Optional Charter Law. Then he read section 1403 of the 3rd Class City Code regarding tax collection. He also said the city's administrative code reinforces state law. He said the city budget exceeds \$100 million dollars and he understands the fear of someone incompetent running for and obtaining the office of city Treasurer. All York County officials make adequate compensation, and the county Treasurer makes over \$86,000. He said he is aware that \$80,000 exceeds the Mayor's salary so Council may feel it may be more appropriate to pay lower compensation for his position. However, the Controller's office and Treasurer's office operations completely separate from the Mayor's office. The Treasurer has to be present daily to do the job. He discussed budget decreases over the past years. He added that his office has generated over \$70,000 for services each year which is more than enough to compensate the salary increase. He said we want to attract competent accountants to this elected position.

President Walker said we need to look at elected officials overall. She stated that when she looked at the Lancaster & Harrisburg Treasurer's office which is comparable to the City of York. She said she agrees that if we want more interest in individuals running for office especially for the amount of work that is expected and required, she said she believes we need to look at this as a collective effort in the future. At this time, she said she is not in favor of going above \$50,000 but this is a step in the right direction.

Councilwoman Buckingham said she agrees with President Walker. She said she appreciates the energy and expertise that Joe brings but we have no control over who will run in the future and or their dedication to this office.

Councilwoman Dennis said she also agrees that we are moving in the right direction, and we need to take small steps.

Councilman Rivera said he's in support of this increase. He said Joe is cut from a different cloth, but he doesn't like being lectured by his supporters. He stated that elected officials are replaceable, and he hopes we are grooming the next officials, but we must keep in mind that someone else may run and win and not have the same standards as Joe.

Manuel Gomez, resident, said he has never heard any negative feedback about Treasurer Jefcoat. He said he thinks we have the right person in the position now but we must keep in mind that this is an elected office. He said he doesn't like seeing the Treasure making a plea directly to the Council for this raise at the podium. He said it seems a little off and should have its own organic impetus.

There being no further discussion, Bill No. 3, Ordinance No. 3, PASSED by the following vote: Y Yeas - Dennis, Buckingham, Rivera, Walker - 4; Nays - 0.

President Walker asked if there was any comment from the Administration. There was none.

President Walker then asked if there was any public comment. There were individuals wishing to comment so President Walker opened the floor for public comment.

President Walker thanked those who volunteer serving on the city's boards and authorities.

Mina Edmonson, Human Relations Commissioner, spoke kind words about Mr. Querry and thanked Council for accepting their nomination of him to the HRC Board and they are pleased to have him join the commission.

Manuel Gomez, resident, said he doesn't think these should be co-mingled into a consent agenda. He said he thinks Council uses this consent agenda method a little too often.

President Walker said when it comes to consent agenda items, it's up to Council. She explained that the consent agenda is done because a lot of discussion happens in committee, so that's the purpose of having committee meetings before acting on legislation. However, if during consideration of final passage, issues with agenda items arise, then Council has the option to request said item(s) to be pulled from the consent agenda for more discussion.

Michael Walker, resident, spoke on agenda item #8 in that when it comes to requests for tax exonerations, Council is setting a precedent and you're going to have other organizations coming to Council asking for exoneration. So, he said be cautious about this because you might not be able to say "no" when other organizations come forward asking for tax exonerations.

Jason Querry thanked Council for considering his appointment and he hopes to serve the city well.

She said we don't have the policies and procedures of the Lancaster Safety Coalition, so we have to take our time to make sure we're doing the right thing.
