CALL TO ORDER: President Walker called the March 7, 2023, meeting to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: Felicia Dennis, Betsy Buckingham, Lou Rivera, Edquina Washington, Vice President, and Sandie Walker, President, with President Walker presiding.

Members of the Administration in attendance included: Kim Robertson, Acting Business Administrator; Joe Jefcoat, Treasurer; Michael Muldrow, Police Commissioner; and Don Hoyt, Assistant Solicitor.

Ī. **Public Comment:**

John Halfpenny, resident, said he recently moved to York from Philadelphia, and he is proud to call York his home. He said about two weeks ago there was a fire about two houses down from him at about 9:30PM. He said the emergency response was phenomenal and thankfully there were no injuries or fatalities, but the building was destroyed. Since the fire, he said the building seems to have been abandoned and nothing is being done about the building. He said there is a property value issue but he's most concerned about this being an attractive nuisance and it's dangerous. The burned property is located a few feet from an elementary school. He said he requests that city officials get involved to evaluate the property and put into place proper safety mechanisms. He said if this were your neighborhood and there is a burned building in your block and kids are 500 yards away, you would probably have the same concerns he is having.

Montez Parker, Sr., resident, asked for permission to approach the Council table. The Council President granted permission. He showed pictures of the burned property Mr. Halfpenny talked about before the property burned. He said there were boarded-up windows before the fire, and trash that was cluttered around the outside of the property that also caught fire. He said the owner came after the fire and removed the burned debris except for the tires. He showed pictures after the fire and how the property is in horrendous condition. He said he talked to the owner multiple times, and he asked if he would go half with him on a fence, so he doesn't have to look at the trash in the yard. He said the owner said he doesn't care because he doesn't have to look at the trash. He said the owner has been given notice to rectify property violations but he's playing the system. He also spoke about parking issues because of parents picking up their kids a Lincoln Charter School. He suggested using other

parking lots that are in close proximity to the school where cars can line up to drop off and pick up their kids from school. He said it might be a small inconvenience for them, but he has been in his house for nearly 30 years, and he's been inconvenienced multiple times over the years trying to get to his home. He said parents are now throwing trash out of their windows into the alleyway. He hopes something can be worked out. He also discussed landlords who don't have trashcans for their tenants. He said the skunks and possums are running him into his house because it's a buffet of trash for them. He said as a solution, maybe the landlord and residents can collaborate and develop a reporting system and have the landlord fine their tenants for not obeying the trash collection ordinance. He also said there is a large amount of debris being left in the alley in the 500 block of W. King St. He said his neighbor didn't put the trash there, but she got a fine for it. He asked if the large item trash pick-up program still exists. Council responded yes.

The City Clerk stated that she would forward these concerns to the administration.

There being no further discussion, the public comment session adjourned at 6:20 PM.
