President Walker asked if there was any comment from the Administration or the public on the consent agenda. There was none.

**Motion to approve consent agenda items.** A motion was made by Buckingham, seconded by Washington, to approve agenda items 8, 10, 11 and 13. The motion to approve PASSED by the following vote: Yeas – Buckingham, Rivera, Washington, Walker – 4; Nays – 0.

Mr. Carden was present and introduced himself and shared how he became interested in serving on the Zoning Hearing Board.

President Walker thanked Mr. Carden for his interest and said we appreciate residents who volunteer to serve our community.

There being no further discussion, Resolution No. 47 PASSED by the following vote: Yeas - Buckingham, Rivera, Washington, Walker - 4; Nays - 0.

City Clerk Thompson then administered the oath of office to Mr. Carden.

Resolution No. 49, Session 2023, A Resolution appointing Brandon Swigart, Nicole Valinteno, Clayton Loeblein, Jared Sutch, David Oaster, Camryn Van Valen, Bryce Shields, and Nathan Moyer as probationary police officers was approved unanimously by consent agenda.

Approving an agreement with Eckert Seamans Cherin & Mellott, LLC for professional legal services (city solicitor) (<u>View</u>) Introduced by: Betsy Buckingham Originator: Mayor

Resolution 50, Session 2023, A Resolution approving an agreement with Eckert Seamans Cherin & Mellott, LLC for professional legal services (city solicitor), which shall not exceed \$250,000.00 per fiscal year, was introduced by Buckingham, read at length, and on motion of Buckingham, seconded by Washington, Resolution No. 49 came up for discussion.

Attorneys Gedd Schweikert, and Brett Flower, Eckert Seamans Cherin & Mellott, LLC, were present to comment and answer questions.

Attorney Schweikert said they are pleased to have a long standing representing the City of York. He said he has been doing special labor counsel for the city for 17 years. He said we have always considered the City of York to be one of our most important clients and we are pleased to be a part of this.

Attorney Flower said she enjoys municipal work and especially the zoning portion and she thanked Council for the opportunity to introduce themselves.

President Walker asked the administration to explain the process.

Acting Business Administrator Robertson said when Assistant Solicitor Jason Sabol gave his notice of resignation, he suggested that we may want to consider a firm to fill the role of solicitor. She said we did an RPF for professional legal services and we received four proposals and this firm scored in the top 2. She said they checked marked everything that we were looking for in the role of an outside firm for city solicitor. Administrator Robertson stated that she worked with Attorney Schweikert for the past several years and we have been happy with his services. They have over 300 lawyers that can be reached out to for assistance. She said we are excited to have them assist us.

Attorney Flower said this is what we do; we act as general counsel to many of our clients and we are used to stepping in and filling that role. She said we're prepared to work with the city during this transition.

Councilman Rivera said if you are serving the administration, there is no way you can serve the Council without there being a conflict of interest. He said you have 300 lawyers and how many are of color and speak Spanish.

Attorney Schweikert\_said he doesn't have a precise number, but he could get that information for him.

Councilman Rivera asked if they have an office in the city.

Attorney Schweikert said our main office is located in Harrisburg, but they will be working out of former city solicitor's office.

Councilman Rivera asked if there is a paralegal.

Attorney Schweikert said we will work with the city's current paralegal.

Councilman Rivera said the city's paralegal doesn't speak Spanish and it would be nice to have someone who can speak the language.

Councilwoman Buckingham said it was a great experience interviewing the parties. Each party was asked the exact same questions. She said during the interview process, she asked how they would represent Council and their responses were great. She said they said we can help you with the law and provide recommendations. She said she's looking forward to working with them.

President Walker said you'll be here at least a week.

Attorney Schweikert said yes, but in the beginning, it might be more frequently as we get caught up. We are always available by telephone, email or zoom, he stated. He added that their plan is to be here tomorrow for our first in-person day and will meet with Pat Siebert, the city's paralegal, to find out her role.

Councilman Rivera said we had an issue where the Mayor did not get sworn into office for his second term and the city solicitor had a different opinion and interpretation of law from other attorney's and Council.

Attorney Schweikert outlined the other municipalities they serve.

Michael Walker, resident, thanked Councilman Rivera for asking the questions. He asked how conflicts of interest are going to be handled between the executive and legislative branches.

Attorney Schweikert said we represent the entire city – meaning Council and the Mayor – and our role is to advise all of you about what we believe the law is and we allow you to make further recommendations if you feel it's needed.

Michael Walker, resident, said we have the executive and legislative branches so he doesn't understand how that will be dealt with. He referred to the situation with the mayor's oath of office.

President Walker said Council has a bit more flexibility when it comes to legal representation as we can seek additional counsel if there is a consensus that there may be a conflict of interest. She said there is a clause in their agreement that addresses conflict of interest but not to the extent of when there is a rift between the executive and legislative branches. If there is a need for additional counsel, she said Council has that option.

Alicia Lacey, resident, asked if there will be a mediator or arbitrator in place to oversee any type of bargaining before the city agrees to a solicitor.

Attorney Schweikert said he's not sure he understands the question but stated that they will represent the city in the collective bargaining agreements process.

President Walker asked if they could discuss the conflict of interest in the engagement letter.

Attorney Schweikert said if a possible conflict, it first goes through a conflict-of-interest check and if there are potential conflicts, the attorney is notified, and a discussion is held to determine whether the conflict should be waived, or we cannot take on the representation because of the conflict.

Councilman Rivera asked Assistant Solicitor Hoyt his opinion.

Assistant Solicitor Hoyt said they are eminently qualified, and he doesn't have a crystal ball but if down the road, the agreement is not working, then the city can say goodbye. He said he has no problem with this.

There being no further discussion, Resolution No. 50 PASSED by the following vote: Yeas -Buckingham, Rivera, Washington, Walker - 4; Nays - 0.
