

Final Passage of Bill No. 33, Ordinance No. 32, Session 2023, A Bill amending the FY2023 budget to allocate ARPA funding in the amount of \$1,000,000.00 for purchase of a new ladder truck and engine for the Fire Department, which was introduced by Washington at the June 6 meeting of Council and read by short title, came up for final passage. On motion of Washington, seconded by Rivera, Bill No. 33, Ordinance No. 32 PASSED by the following vote: Yeas - Dennis, Buckingham, Rivera, Washington, Walker - 5; Nays - 0.
