The CDBG balances reflect 2023 funds addition. Demolition has challenges because so much of the City is in The Historic District and to demolish a structure there requires permission from the State Preservation Board.

VI. (a.) 330,332,334 S. Duke St

Randy and Haley Durkee are asking to purchase two (2) vacant lots and the structure at 334 S Duke. They are offering \$1,000.00 for the structure and \$500.00 for the two (2) vacant lots which were not originally in their plans. Staff advised they are great to work with do good work and have the best interest of the City at heart.

Teen Vebares moved to approve the sale on those terms. Joyce Santiago seconded. Motion passed unanimously.

(b.) 570 Company St.

This property was donated to the Authority. Mr. Elliot Hogue of Kingdom Building and Restoration is offering to purchase the property for \$1,500.00. He has secured financing. Staff advised he has a good history including on West Clarke Avenue.

Aaron Anderson approved the sale on those terms. Joyce Santiago seconded. Motion passed unanimously.
