VI. (a.) 254-256 S Queen St.

The developer is requesting an extension of the Option from November 4, 2022, to May 31, 2023. Staff is proposing no fee under the circumstances.

Frank Countess moved to approve the extension. Aaron Anderson seconded. The motion passed 4-0. Joyce Santiago abstained.

(b.) Social Enterprise Group

Staff is requesting authorization to negotiate terms of a pre-development agreement. Joyce Santiago moved to approve the motion. Teen Vebares seconded. Motion passed unanimously.

Staff is requesting authority to open 2 separate accounts- one for Penn market RACP and the other for real estate projects. Teen Vebares moved to approve. Joyce Santiago seconded. Motion passed unanimously.

(d.) Steven Teachout gave an update on Citizens Bank-He is investigating restaurants. There was an asbestos review showing minimal concerns. The Preliminary Design investigation shows some light interior demolition will be performed to see what the walls look like. There was raw sewage in the basement. He hired Serv Pro to help. He wants to bring more Tech to York, He said he is here because he was invited and that works. Michael Black thanked him for the update and had some restaurant questions. Mr. Teachout replied he is thinking about "Taste of the Town" which would involve many styles. Frank Countess stated a restaurant in Nashville with a giant three-foot pizza in The Baker Building sounds fascinating.

VII. Staff Report

(a.) A \$1.5 million RACP grant is being awarded for the Health Bureau at the Newcombe Center. City council will match it in the 2023 budget. The Authority will be the owner and landlord.

Frank Countess asked about the \$1.5 million RACP grant for Farmers market. That did not increase.

(b.) 385 Lexington settled. \$5600.00 was paid. It was a good project.

- (c.) 115 Rathton is ready to settle. The price is \$70,000.00. When there is an open house, invitations will go out.
- (d.) A Board of View is set for January for 701-703 Prospect.
- (e.) Frank Countess stated 320 North George was sold to Gilliland and there will be two tenants. McNees Law Firm and Web FX.
