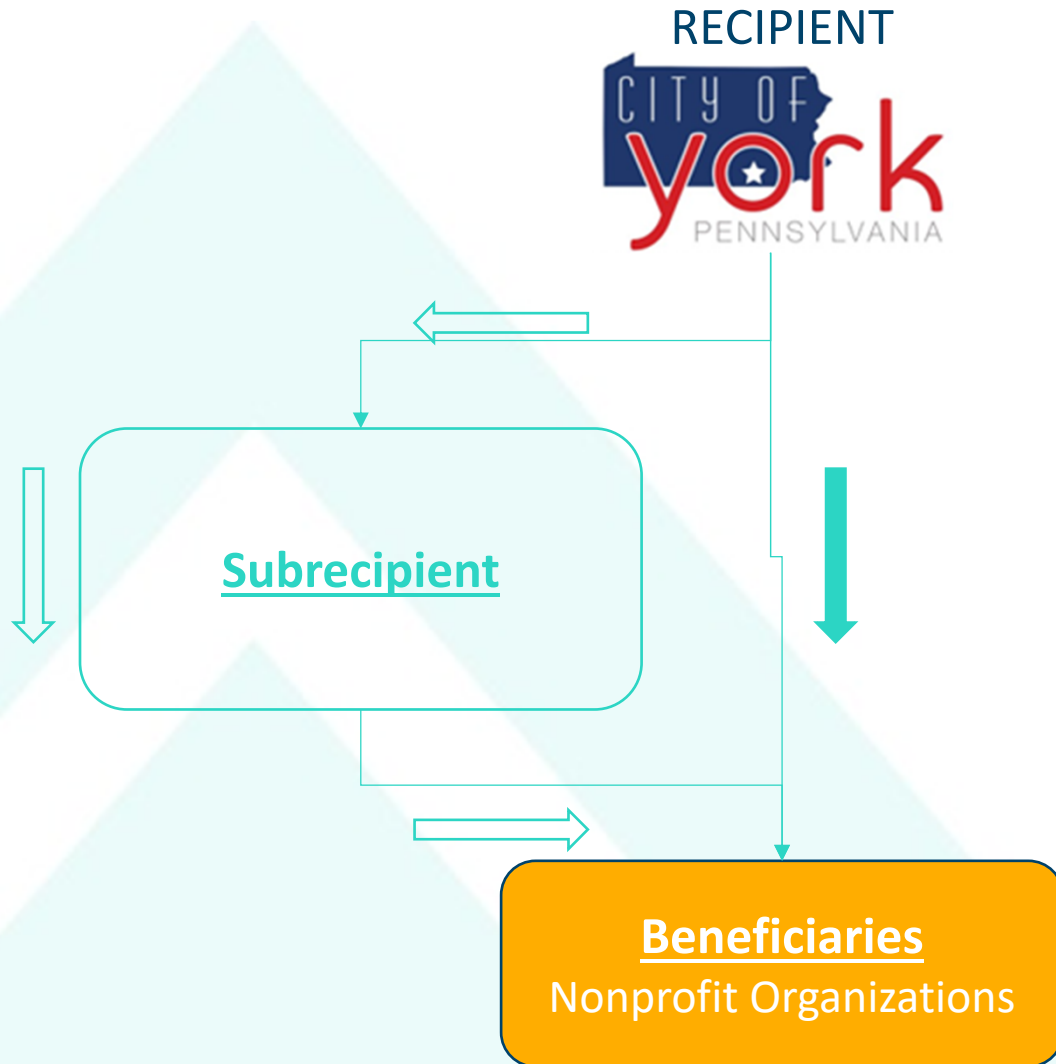

Subrecipient

- Determines who is eligible to receive Federal assistance
- Measures performance based on meeting objectives of the Federal program
- Is responsible for programmatic decision making
- Is responsible for ensuring Federal requirements outlined in the award are followed
- Uses the Federal funds to carry out a program as opposed to providing goods/services

Beneficiary

- Is an individual or organization receiving the funds as the end user or entity directly benefitting from the financial assistance
- Does not determine eligibility or compliance

- Federal Assistance Listing Number: 21.027
- Available to non-profits that carry an active 501(c)(3) or 501(c)(19) status
- Must provide evidence the organization is located within the city or serves city residents.
- Must clearly demonstrate negative economic impact due to COVID-19 through the organization's financial documentation and application narrative.
- Demonstrated impacts may include:
 - Decreased revenue (e.g., from donations and fees, shutdowns, etc.)
 - Increased expenses (e.g., uncompensated increases in services, etc.), or
 - Evidence of COVID-19 related expenditures (PPE, cleaning supplies, social distancing measures, signage, etc.)

- Funding request must be reasonably proportional to the demonstrated impact
- Impact analysis calculation will determine a total estimated impact by assessing a loss in revenue and total uncompensated estimated increase in expenses (or direct COVID-related expenditures) during COVID years using the grant narrative and financial documentation provided.
- Estimated impact will then be reduced by any alternate funding your organization has received for COVID-related impacts between March 2020 and the time of application (CARES, PPP, EIDL, etc.) to determine the remaining “unmet need”.
- Applicant’s “unmet need” will be eligible for funding up to the capped grant amount (\$45k) and total program funding allocation (\$1M) available.

Funding to mitigate financial hardship

- Mortgage, rent, utility and other typical operating costs including payroll and staff
- Technical assistance including non-profit development
- Other services to support business planning

Funding to cover costs associated with COVID-19 mitigation and prevention strategies

- Personal protective equipment (gloves, masks, hand washing stations, etc.)
- Ventilation system installation or improvements
- Communication and awareness effort
- Support for isolation/quarantine
- Monitoring/contact tracing surveillance
- Costs associated with technology solutions for remote service delivery

Scoring will be conducted by a panel, using the following criteria:

- Organization's good standing with the city
- Magnitude of alternate funding received to date
- Magnitude of remaining unmet need compared to latest year's revenue
- Total households/residents served by the organization annually
- Total estimated number of underserved populations served by the organization annually
- Location within the city (QCT tracts or disproportionately impacted areas)
- Other criteria as deemed appropriate by the panel

The grant application process is streamlined through the city's online OpenGov grant management portal.

- c. Once at the grant portal, click apply and follow the prompts to create an account.

- a. Follow the steps on the Open Gov portal, see step 1.
- b. Complete the application.
- c. Visit the URL above to download the required documents.
- d. Attach the completed forms to your document when prompted in the portal.
- e. Submit application.
