**WHEREAS**, in accordance with Ordinance No. 10 of Session 1999, the Council of the City of York, Pennsylvania (Council) has the authority to adopt by Resolution inspection and licensing fees to be imposed in accordance with Article 1761 of the Codified Ordinances for the City of York, Pennsylvania (City), and

**WHEREAS**, said fees have not been adjusted since April 1, 2012, while cost have increased;

**NOW THEREFORE, BE IT RESOLVED**, that Council approves the following tenant occupied license and inspection fee schedule to take effect for the 2024N license year:

LICENSE FEES	
Group I-1	\$76 per bed
Group I-2	\$66 per bed
Group I-3	\$66 per bed or a flat fee of \$130 for institutional facilities without beds
Group I-4, Group R-4 And Group E Daycare	\$66 plus \$8.00 per person served <sup>1</sup>
Group R-1	\$76 per sleeping unit or rooming unit
Group R-2, R-3, R-4, or Group R-5	\$76per dwelling, sleeping unit or rooming unit
Group R-3 congregant living facility	\$76 per approved bed
Group R-2 or R-3 Day Care	\$66 flat fee

<sup>1</sup>Based on the approved occupant load.

INSPECTION FEES	
Group I-1, I-2, and I-3	
One (1) to Ten (10) beds	\$76 per bed
More than ten (10) beds	\$760 minimum <sup>1</sup> plus \$76 per hour, per inspector <sup>2</sup> billed in ¼ hour increments
Group R-1	
One (1) to Ten (10) sleeping or rooming units	\$76 per sleeping or rooming unit
More than ten (10) sleeping or rooming units	\$760 minimum <sup>1</sup> plus \$76 per hour, per inspector <sup>2</sup> billed in ¼ hour increments
Group R-2, R-3, R-4, or Group R-5	
One (1) to Ten (10) dwelling, sleeping or rooming units	\$76 per dwelling, sleeping or rooming unit
More than ten (10) dwelling, sleeping or rooming units	\$760 minimum <sup>1</sup> plus \$76 per hour, per inspector <sup>2</sup> billed in ¼ hour increments
Group R-3 congregant living facility	\$76 per approved bed
Group R-2 or R-3 Day Care	\$66 flat fee

<sup>1</sup> Inspection fee includes one inspection, each reinspection shall incur the original inspection fee and must be paid prior to scheduling of the reinspection.

<sup>2</sup>Paid at time of license application

<sup>3</sup>Billed after inspection.
