CALL TO ORDER: President Washington called the February 6, 2024 meeting to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: Teresa Johnescu, Elizabeth Bupp, Felicia Dennis, Betsy Buckingham, Vice President, and Edquina Washington, President.

Members of the Administration in attendance included: Kim Robertson, Business Administrator; and Brett Flower, Assistant Solicitor.

City Council Staff in attendance included: Dianna L. Thompson, City Clerk.

I. Public Comment:

Marilyn Hake, resident, said while on the Rail Trail off of Kingsmill Rd. by the ice company, is a homeless encampment and the debris and trash stretches beyond their encampment.

Councilwoman Johnescu said she was on a walk with Mrs. Hake and witnessed this herself.

Business Administrator Kim Robertson said the Administration is aware of the homeless encampment and they are working on it.

Derrick Mannifore, Esq. said he is representing Mr. Themi Sacarellos who owns many properties including Roud-the-Clock Diner. He said Mr. Sacarellos is interested in leasing 1601 Toronita St. or purchasing it. Attorney Mannifore said Mr. Sacarellos has developed in the surrounding area is willing to pay market rate. He said he just wants to put this on the record that his client would like to lease or purchase the property.

Themi Sacarellos, owner of Round the Clock Diner, said he is developing various businesses, including the former San Carlos. He said the property is in disrepair and he's hoping to renovate the property and make it better for the community. He said he also redeveloped the old Bob Evans and made it a Starbucks. He named several other properties he developed into businesses.

President Washington said she'll share said interest with the Department of Economic Development.

She then shared statistics on poverty and said it's our job to help get people on their feet and to becoming self-sufficient. She said they look at several factors to help individuals reach economic self sufficiency and change the lives of children and their families. She said we look forward to partnering with the city and she thanked the city for supporting their efforts. She thanked Vice President Buckingham for serving as a board member.
