NEW SIGNAGE INSTALLATION – 2 PROJECTED BANNER SIGNS ALONG PHILADELPHIA STREET (NOTLIT). 1STANDING MONUMENT SIGN ALONG PERSHING AVENUE (INTERNALLY LIT), 3 PARALLEL BANNERS ALONG PERSHING (NOT LIT), ALL BRACKETS, HARDWARE AND ATTACHEMENTS SHALL BE MATTE BLACK IN COLOR AND INSTALLED INTO BRICK MORTAR JOINTS. EXISTING LOCAL AND NATIONAL PRECEDENTS.
