LUMBER WITH COMPOSITE LUMBER DECKING. THIS ADDITION OF A NEW GAZEBO AND DECK WILL BELOCATED IN THE RECESS YARD. THE DECK WILL CONSTRUCTED OF 2X10 PRESSURE TREATED LUMBER SET ON PAVERS. THE DECK FLOOR WILL BE CONSTRUCTED OF COMPOSITE DECKING LUMBER. THE GAZEBO WILL BE PURCHED FROM AMAZON AND WILL BE PLACED ONTO THE NEW DECK AND THEN BOLTED FAST TO THE DECKING STRUCTURE. ON AUGUST 27<sup>TH</sup> OF 2022, THE BUILDING AT 46-48 W. PRINCESS ST. WAS DEMOLISHED AND THE SPACE BACKFILLED AND RE-GRADED. ST. PATRICK'S CHURCH WOULD LIKE TO TAKE UP APPROX. 2144 SQUARE FEET OF THAT SPACE WITH THE PROPOSED GAZEBO STRUCTURE.

#### Discussion:

Applicant stated that once the building came down, they needed to have shade for the kids and a place where they can read and write. Discussed the pictures for what the gazebo will look like. Will take up part of 42 W. Princess St. Can see from street. Well designed structure. Secured to the ground with a hurricane pine. Deck would not be more than a foot high. 2 picnic tables under gazebo. For teachers to keep an eye on kids. Can use for emergency drills as well. 144 square feet total surface. Applicant, maintenance man, and students and faculty involved. Mr. Skehan is a member of the church and stated had a potential conflict of interest.

### Action.

Mr. Shermeyer made a motion to approve the application as submitted with the structure sitting on a concrete slab on grade or 1 foot high above grade wood deck, Ms. Hitzel second. Unanimous.
