CALL TO ORDER: President Washington called the April 15, 2025, meeting to order at 6:00 p.m. in Council Chambers, 101 S. George St., York, PA, with the following members present: Elizabeth Bupp, Teresa Johnescu, Felicia Dennis, Betsy Buckingham, Vice President, and Edquina Washington, President with President Washington presiding.

Members of the Administration included: Kim Robertson, Business Administrator; Tammy Harvey-Bethea, Director, Bureau of Housing Services; and Assistant Solicitor Brett Flower.

Council Staff in attendance included: Dianna L. Thompson, City Clerk.

I. Public Comment:

Todd Moritz, resident, discussed parking issues on N. Franklin St. in that there are two garages on the street, and the garage employees and customers take up all the parking spaces on the street. He said sometimes the cars are parked there for days. He said there are even cars that have been parked there for 10 years. He said he contacted the Planner and Zoning Officer and reported it, but to no resolve. He said they have flatbeds parked on the street, they are working on cars, and oil is all over the street and sidewalk. He said he doesn't want to leave his neighborhood, but he might have to do that because he is at his wits end.

Monica Kruger, Director of Health, announced that last week was National Public Health Week and she applauded health workers for their service. She stated that the health department is celebrating over 40 years of community service. She also discussed federal funding cuts that have affected the City of York. She said grants awarded during the COVID-19 pandemic for infrastructure and public health services are under attack and that Governor Josh Shapiro and 22 other states are taking legal action against the decision to cut funding, which has resulted in a temporary restraining order to stop termination of these funds. She said their funding cuts are now under review, and they are fighting to keep those funds but are looking at other options if the funding isn't dispersed and how those cuts will affect their programs.

Benjamin Praster, President of the FOP, asked that City Council take action into investigating Human Resources and Business Administration. He said they went through contract negotiations and were working outside of a contract for years. He stated that FOP members were entitled to backpay, but unfortunately, backpay was not calculated correctly; some were paid significantly less while others were paid significantly more. He said the FOP started contacting HR to get this corrected. He said he requested a meeting to discuss this but no one from the administration was available. He said he doesn't understand why the calculations are not readily available to review because these numbers didn't just come out of thin air. He said he believes the administration made a bunch of errors and they are trying to cover it up. He asked Council to look into this and hold the administration accountable.

There being no further discussion, the public comment session adjourned at 6:15 p.m.

► PAWC Discount Program - Tawana Dean, Senior Manager, Customer Compliance, Pennsylvania American Water Company (PAWC) - Brief presentation on discount program for city residents.

Tawana Dean, Senior Manager of Customer Compliance, outlined multiple assistance programs for wastewater customers, including:

♦ A Bill Discount Program for households earning below 200% of the federal poverty level.

♦ A payment arrangement plan, called the "Overage Management Plan," which reduces monthly bills and forgives overdue balances over time.

♦Grants of up to \$500 for eligible customers with income up to 250% of the federal poverty level.

♦Conservation kits to reduce water usage and costs. These programs aim to prevent service terminations and support struggling households in the York area. Applications can be processed through community partners like Dollar Energy Fund, Salvation Army, and others.

Councilwoman Johnescu said after review by the Mayor, he requested that section 181.09 requiring a "thank you" letter be sent to outgoing board members be removed. She said she agrees that we cannot legislate professionalism, but she hopes that this will be a normal policy and practice to recognize our outgoing members for successful completion and service on our boards and authorities.

The motion to amend was seconded by Washington and passed unanimously.
