She said her daughter has also been able to purchase vapes and edibles. She said this seems to be the norm for these smoke and chill stores to serve to underaged children. She said she hopes something can be done to prevent these stores from selling to children.

Manuel Gomez, resident, said he sent Council suggested language to supplement the standing drone policy. He said these are based off credible institutions. He said data retention was a major issue for him and there was no policy for retention. He said his request is 24 hours for any

data captured that's considered relevant. He said we shouldn't be piecemealing a drone policy.

Motion to amend. Councilwoman Bupp recommended amending language to add the following language to Section One of the bill, "WHEREAS, City Council requests with the passage of this Bill that the City of York Police Department review and revise as appropriate its policies pertaining to the use of drones in policing;" The motion was seconded by Washington and passed by the following vote: Yeas – Bupp, Dennis, Washington – 3; Nays – Johnescu, Buckingham – 2.

Final Passage of Bill No. 13, Ordinance No. 13, Session 2025, A Bill amending Article 1761 "Licensing and Inspection of Tenant Occupied Residential and all Institutional Occupancies" of the City of York Codified Ordinances to establish requirements for local supervision of residential rental units and providing definitions, therefore, which was introduced by Buckingham at the May 6 meeting of Council and read by short title, came up for final passage. On motion of Buckingham, seconded by Johnescu, Bill No. 13 came up for discussion.

Councilwoman Bupp stated concerns with the definition of disruptive conduct fund in section 1761.03. She said it addresses defines disruptive conduct by a tenant but there is no penalty or action that the landlord has to take to address that conduct. She feels definition lacks sufficient reinforcement and needs more teeth.

Councilwoman Johnescu thanked Vice President Buckingham and DCED staff for working on this legislation and said this is long overdue. She said our renters deserve a better quality of life and she hopes this moves the needle in the right direction.

Vice President Buckingham said she has been working on this for several months with DCED staff. She said her main concern was that out-of-state landlords be required to have a local manager because we have had landlords as far away as Hawaii. So, the amendment to have local management was needed and we were able to make other amendments as well.

Manuel Gomez, resident, said some of the language disturbs him such as it doesn't have to be a criminal offense it's just the presence of a police officer or multiple calls to the police. He asked what protections there are to protect women against violence. He questioned how we can protect those who have already been harmed by domestic violence. He asked Council to keep in mind that we have a vulnerable population. He said this language is similar to prior language that was problematic. He said if he's playing music too loud is that going to be an offense under this ordinance.

There being no further discussion, Bill No. 13, Ordinance No. 13, PASSED by the following vote: Yeas - Johnescu, Dennis, Buckingham, Washington - 4; Nays - Bupp - 1.
