Architectural shingles Jf Timberline or equivalent black recommended. Metal porch roof. Ice and water shield recommended.

#### Action:

#### Case #2 - 245 E. POPLAR ST.

CURRENT CONDITION RQUIRES STRUCTURAL REPAIRS TO REPLACE OMPROMISED 2x8 RAFTERS, RESHEETING TO EXISTING SPECS, INSTALL RUBBER ROOFING ON FLAT ROOFING SURFACES, REPLACE ASPHALT SHINGLES ON MASNSARD IN FRONT OF ROOF TO EXISTING SPECS. 30 YR ARCHITECTURAL SHINGLES.

#### Discussion:

The applicant stated just approval for the roof will return later once full renovation. Just need for stabilization. Purchased from RDA. Mansard with shingles now and rubber roof. Applicants propose the same in-kind. Ms. O'Brien applicated the applicant for saving structure.
